PROPOSAL

Demolish the non-contributing 1946 frame one-story residential building and construct a new 1 and a half story frame and stucco building.

ARCHITECTURE

The building is a cross gable- single story brick building with two front facing gables and a recessed entry. It is vernacular in nature with no character defining architectural features.

PROJECT SPECIFICATIONS

Demolish the existing building and build a new modern single family residence. The building will be a primarily one story building with a clearstory in the center. It will be a metal frame building with a stucco finish. The front façade has a partial width covered porch with a centered French door. The entrance is centrally located on the façade. A two car garage is also on the street façade. The roof structure is a V shaped roof with both the west and east ends sloping to the middle of the building. The north facade has a regular rhythm of windows that with a glass curtain wall and door centrally located on the façade. The south elevation has an irregular pattern of windows with varying sizes over the façade.

HISTORY OF THE PROPERTY

The property was built in 1946 by a development company. It was listed as vacant in the 1947 directories and has Wendell and Ann Anderson listed in the 1949 directory. Starting in 1955 for about a decade Diaz and Mary Callahan owned and lives in the property. After Diaz died in 1961, May remained at the property and worked at Bergstrom Air Force Base. From the late 1960s onward the property was owned and lived in my Medina and Donna Trinidad. Medina worked at Portman Plumbing and Heating.

STANDARDS FOR REVIEW

The house is contributing to the Old West Austin National Register Historic District. The Secretary of the Interiors Guidelines does not have specific guidelines for new construction. General design guidelines in historic district stress the importance of maintaining a regular street pattern and to design additions and infill construction with a size, scale, and materials compatible with the historic character of the neighborhood and the other contributing houses within the district.

STAFF RECOMMENDATION

Postpone the application until the applicant has completed the Technical Building and Zoning reviews and have met the applicable code standards. The design of the building could change due to these standards.
