Onion Creek Metro Park



PARK BACKGROUND

The Onion Creek Metro Park is 555-acres of parkland located in southeast Travis County, just south of Onion Creek. The city-owned park is relatively flat, wooded and sits undeveloped. The 180-acre Onion Creek Greenbelt is north of the Onion Creek, which is 79 miles in length. The Onion Creek Metro Park was purchased by the City of Austin in the late 1990s, making it the largest city-owned park in Austin. Nearly 15 years later, a new funding source creates an opportunity for long-term, ongoing maintenance to be used to build and maintain the parkland.

POTENTIAL ONGOING FUNDING SOURCE

Once improvements to the park are made, as described in the Master Plan, funding for maintenance and operations costs can come from a newly formed Onion Creek Park District. The Park District was created in 2013 by the Texas Legislature specifically to provide ongoing funding for the Onion Creek Metro Park through fees charged to homeowners in the yet to be developed adjacent Goodnight Ranch community.

HISTORIA DEL PARQUE

Onion Creek Metro Park forma 555 hectáreas de zonas verdes situadas en el sureste de Travis County, justo al sur de Onion Creek. El parque, cuya propiedad permanece a la ciudad, es relativamente plana, arbolada y se encuentra sin desarrollar. Esta ubicada dentro de los 211 kilómetros cuadrados de la Cuenca de Onion Creek donde la longitud total del arroyo es de 79 millas. Los 180 acres del Onion Creek Greenbelt se encuentran al norte de Onion Creek, y Metro Park se extiende sobre 2.5 millas del arroyo. Onion Creek Metro Park fue comprado por la ciudad de Austin a finales de 1990, lo que lo convierte en el parque más grande de la ciudad de Austin. Casi 15 años después, una nueva fuente de financiamiento crea una oportunidad para que el mantenimiento a largo plazo continúe y se utilice para construir y mantener el parque.

POSIBLE FUENTE DE FINANCIAMIENTO

Una vez que se realicen los mejoramientos en el parque, como se describen en el Plan Maestro, la financiación de los costos de mantenimiento y de operaciones pueden provenir de un recién formado Onion Creek Park District. El Park District fue creado en 2013 por la Legislatura de Texas específicamente para proporcionar una financiación continua para el Onion Creek Metro Park a través de las cuotas cobradas a los propietarios de viviendas en la futura comunidad Good Night Ranch.

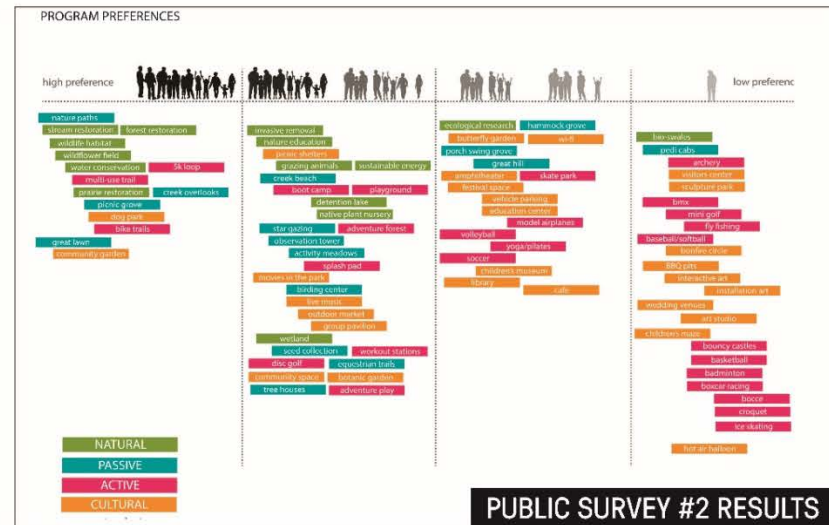
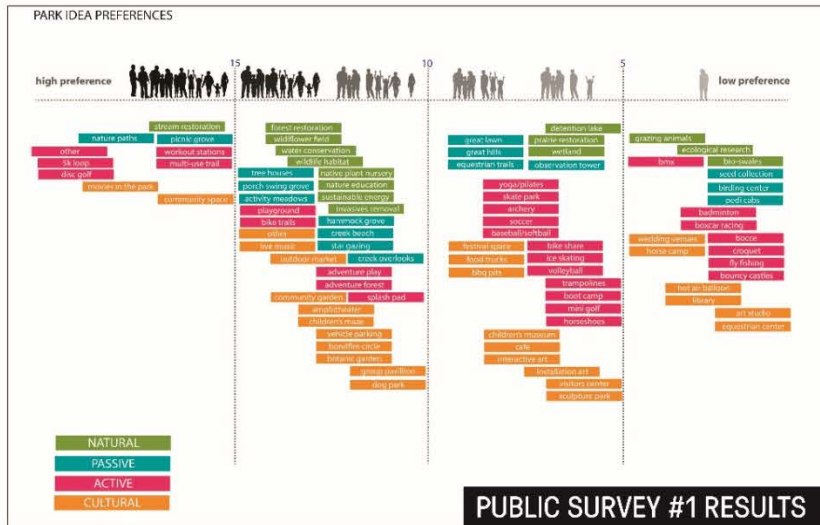

Public Survey Results came from comment cards filled out in person at the previous meetings as well as from online surveys that went live on the City of Austin's website after the public meeting for a period of several weeks. These results were compiled and analyzed by the team, which influenced the program distribution in the draft master plan.

"It is well thought out and works to meet the **needs of many park patrons**. It uses land that would otherwise be vacant"

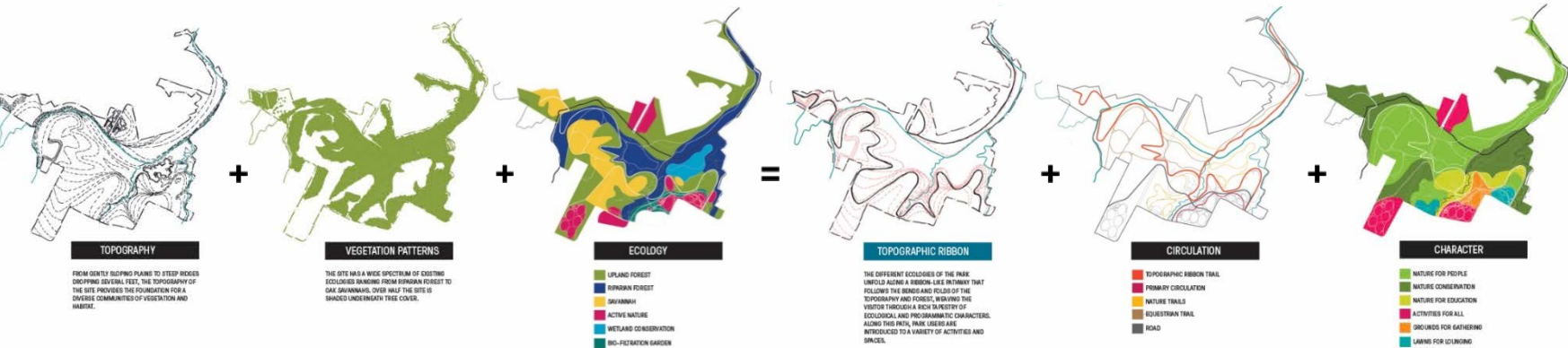
"Want a quite place to meditate, dream and **enjoy nature** with lots of benches

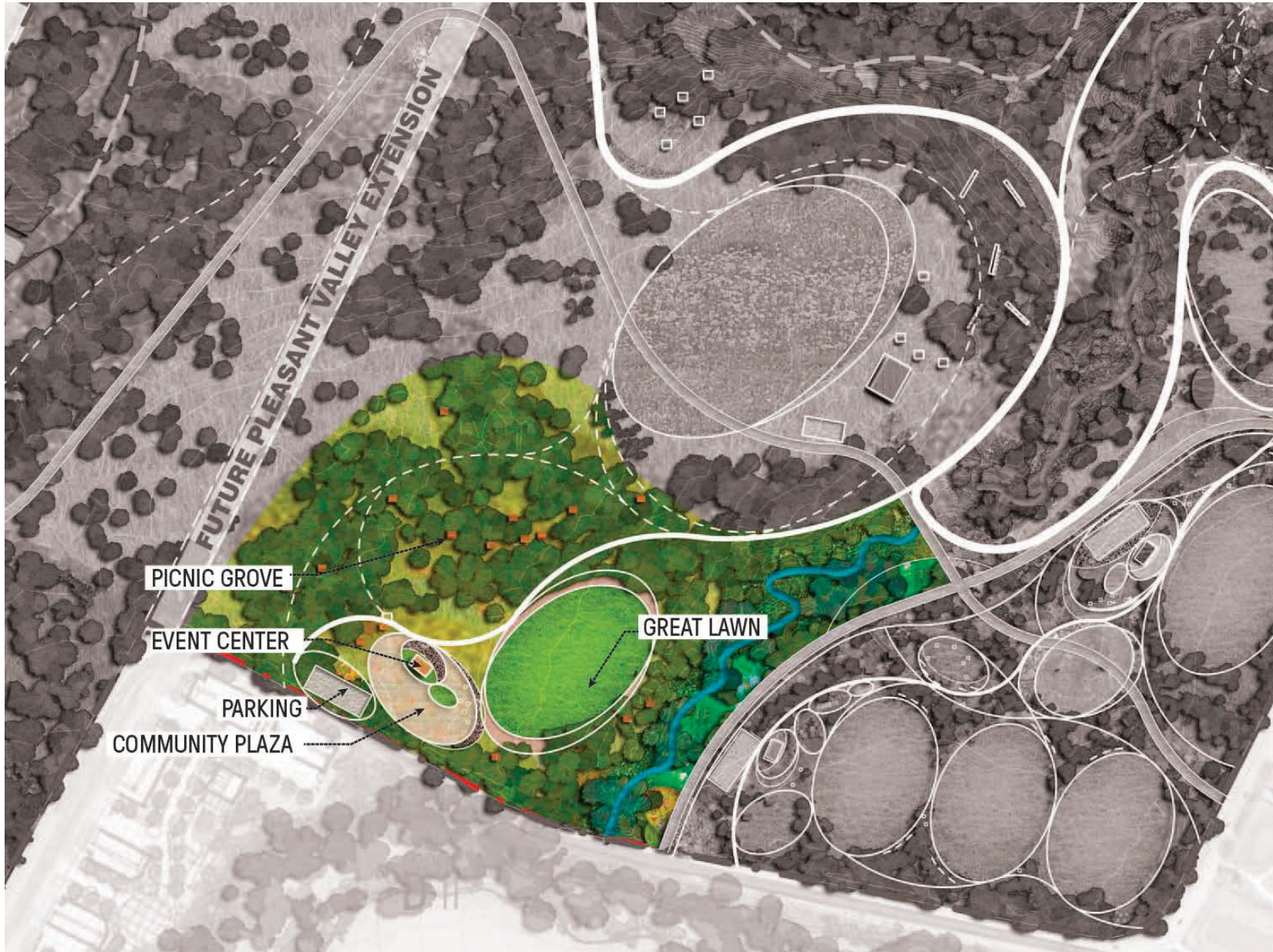
Site Analysis

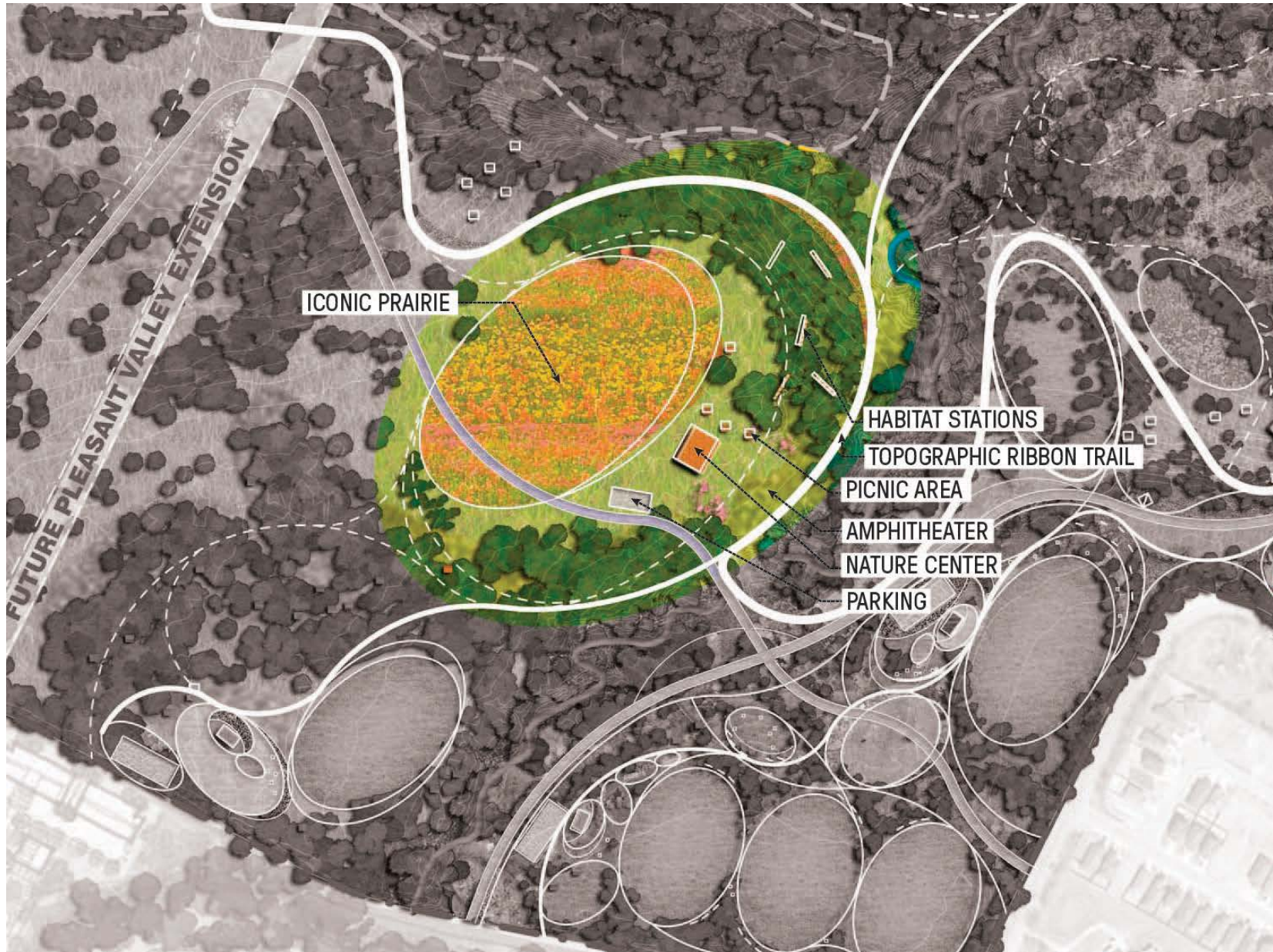
Community Events Area



Playfields and Recreation Area



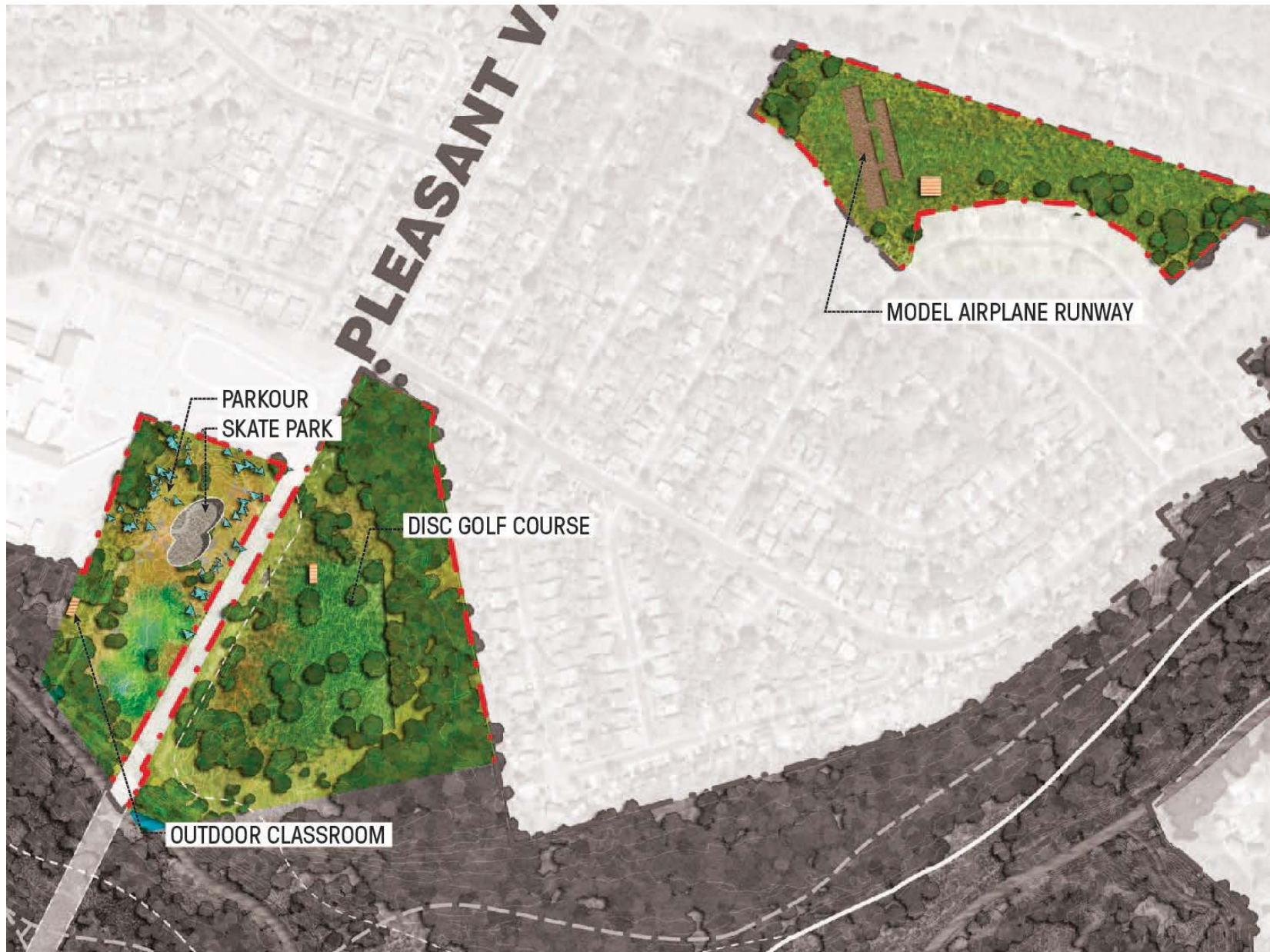
Nature Center Area
