# Code Advisory Group makes preliminary draft recommendations

By a vote of 8-0, the Land Development Code Advisory Group has moved to share Working Group recommendations with the CodeNEXT team.

You can review the recommendations here.

As Opticos Design prepares a preliminary draft of the new code, it will call upon the input gathered from three CAG teams on the topics of affordability, infill/compatibility/missing middle housing and small business obstacles.

The CAG working groups met from January to April, discussing best practices used in other cities. The participants also framed the discussion around the question "How might we...?" in order to tackle some of the possible barriers within the three challenge areas.

The CodeNEXT consultants will work on the preliminary draft from May 2015 to January 2016.

# **Green Infrastructure working group continues**

The Green Infrastructure Working Group, led by the Watershed Protection Department, will hold its next meeting from 2 p.m. to 5 p.m., Friday, May 15 at the Town Lake Center Assembly Room 130 (721 Barton Springs Road).

The meeting will cover stormwater options for redevelopment and infill. In its last meeting in April, the group covered the beneficial use of stormwater. You can review the presentation and meeting notes <u>here</u>.

The Green Infrastructure Working Group examines how the land development code can encourage the broader vision of green infrastructure established by Imagine Austin: "an interconnected system of parks, waterways, open space, trails, green streets, tree canopy, agriculture, and stormwater management features that mimic natural hydrology."
