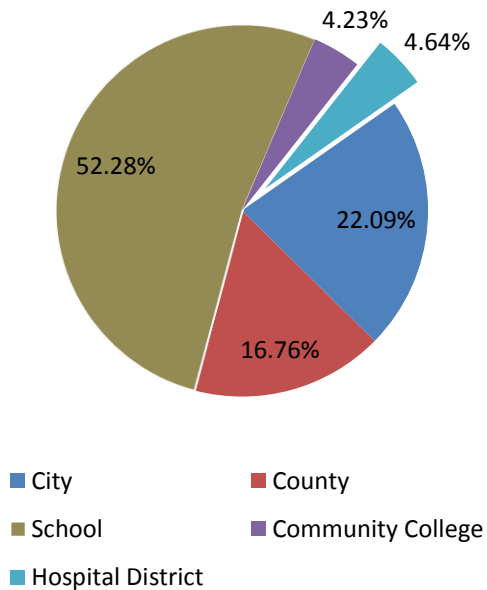

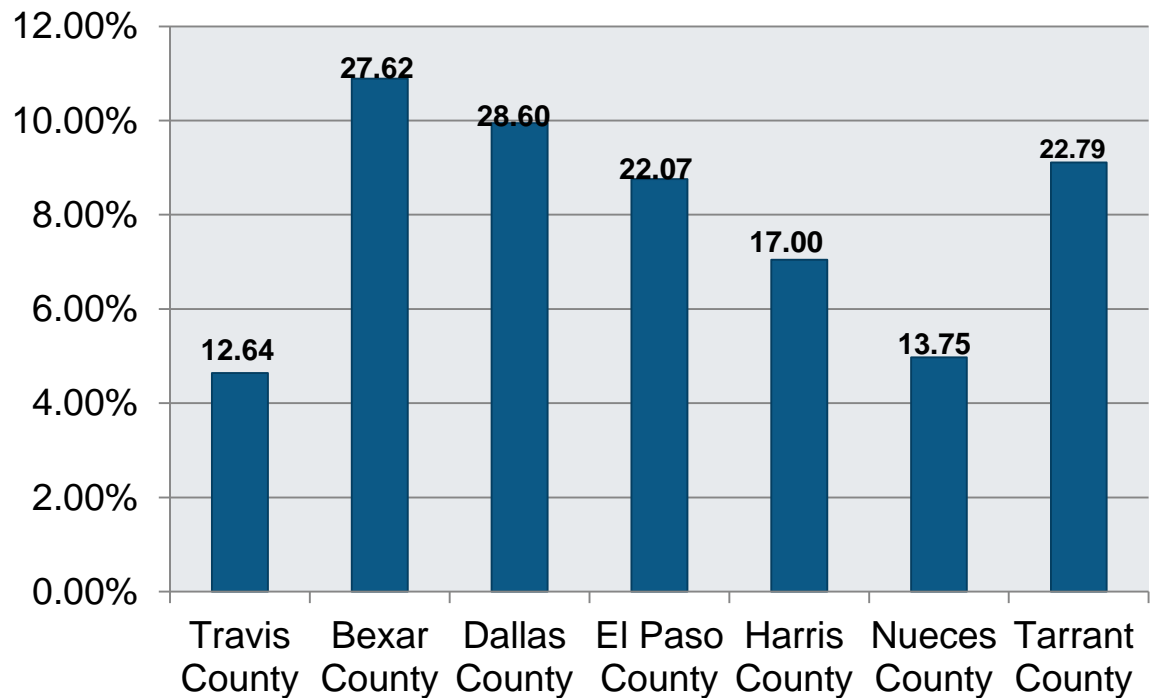

Property Tax Rates

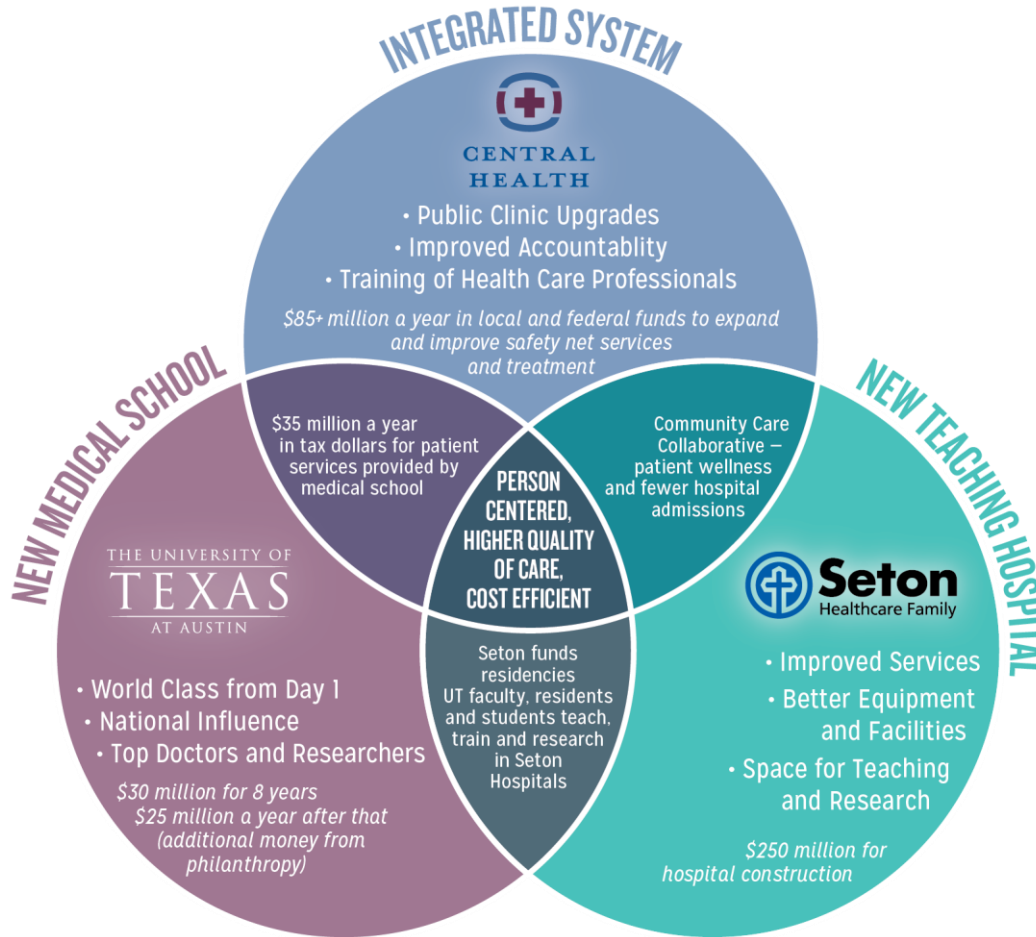
Travis County Tax Entity %

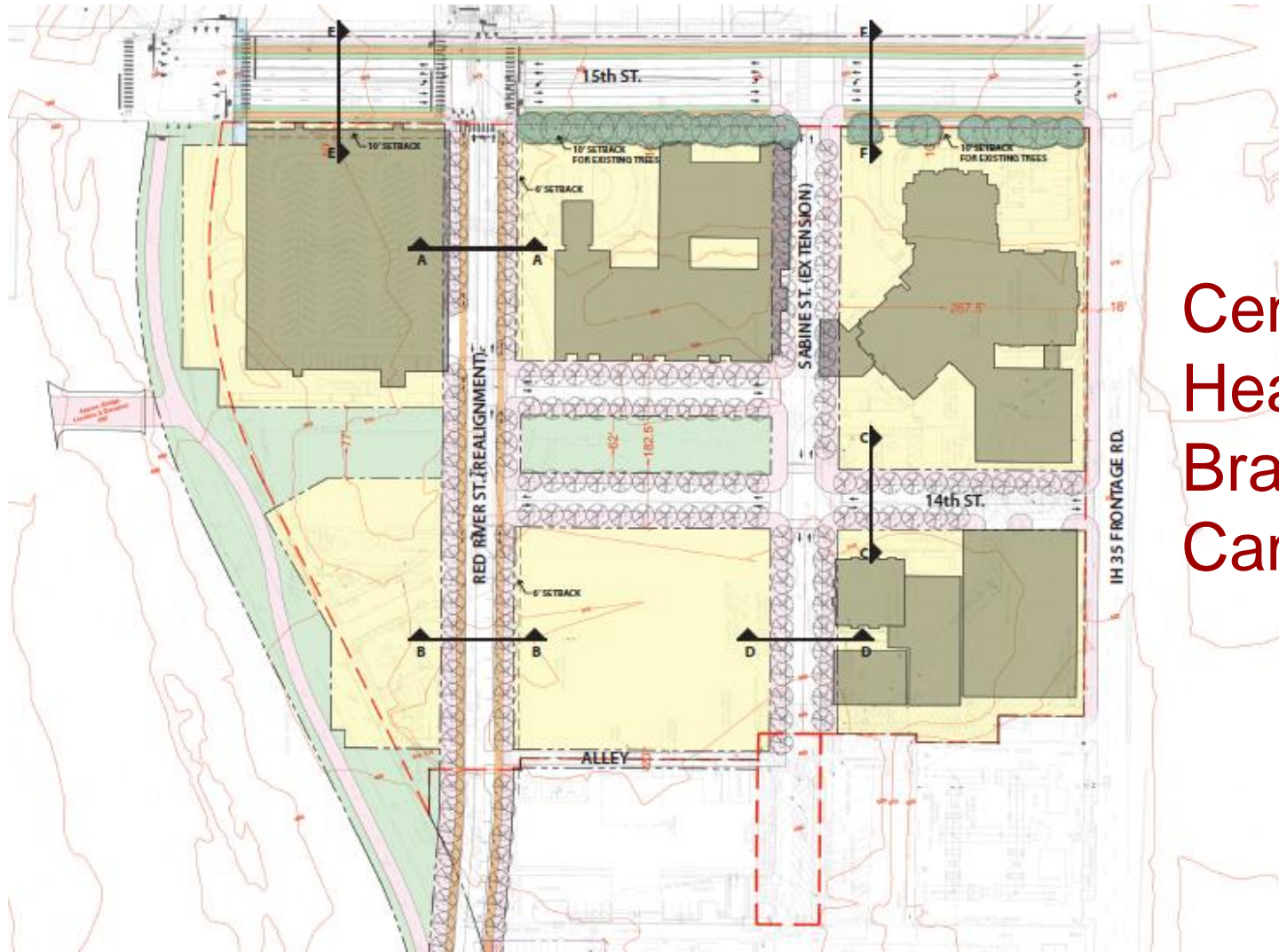
3. PARTNERSHIP

Strengthen and expand relationships with health and wellness providers, collaborate with other public-sector entities, and help advance the goals of the larger community.



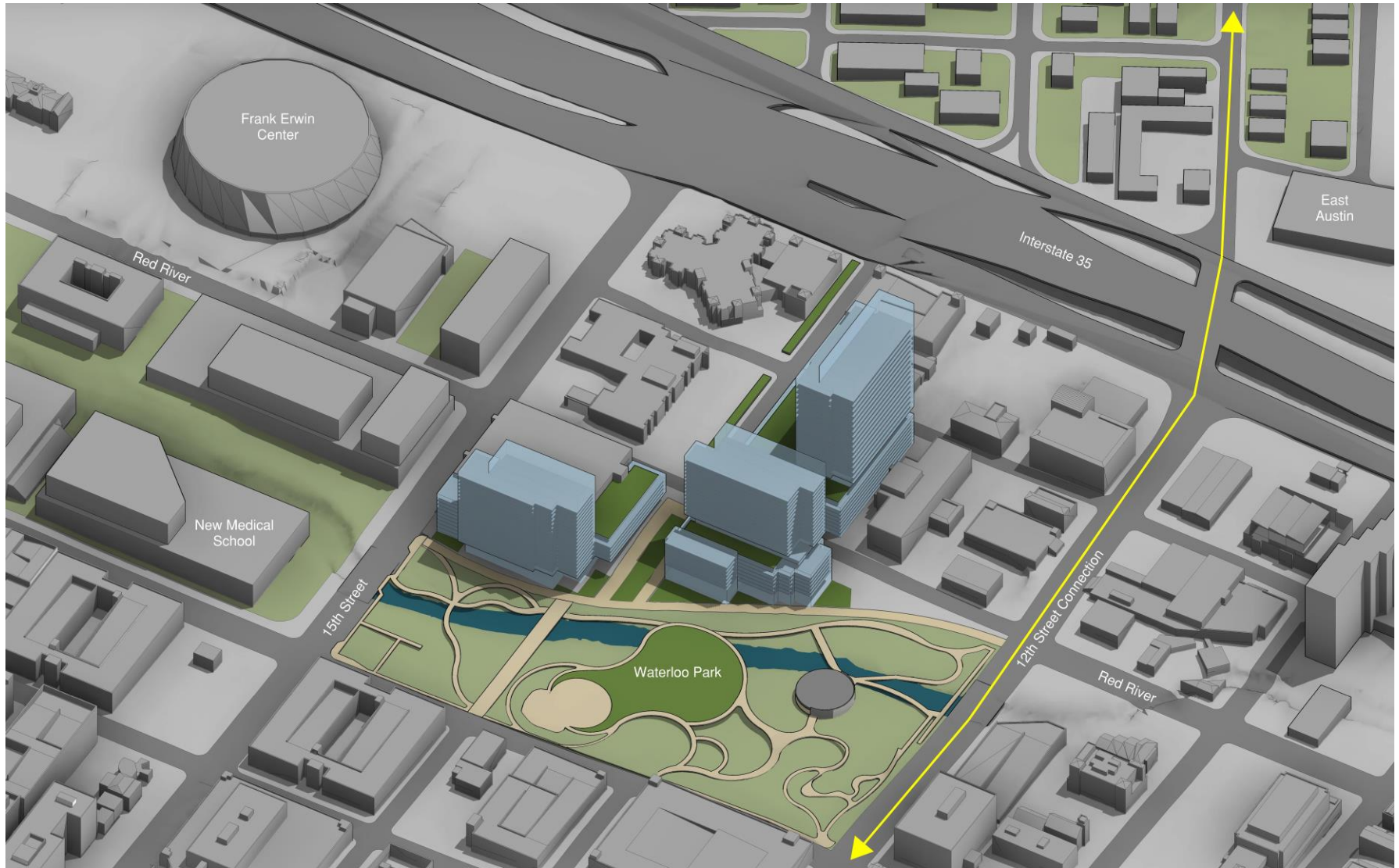

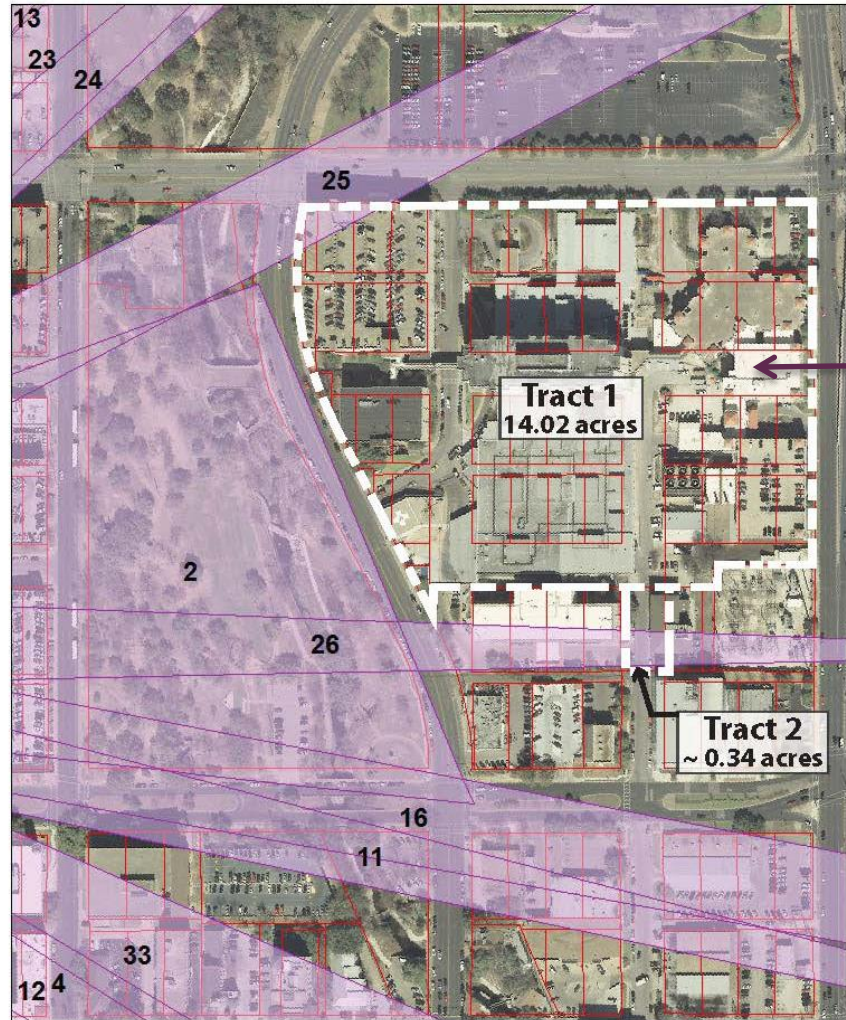

The State and City-legislated Capitol View Corridor which limits building heights has very little impact on the Brackenridge Campus Redevelopment.



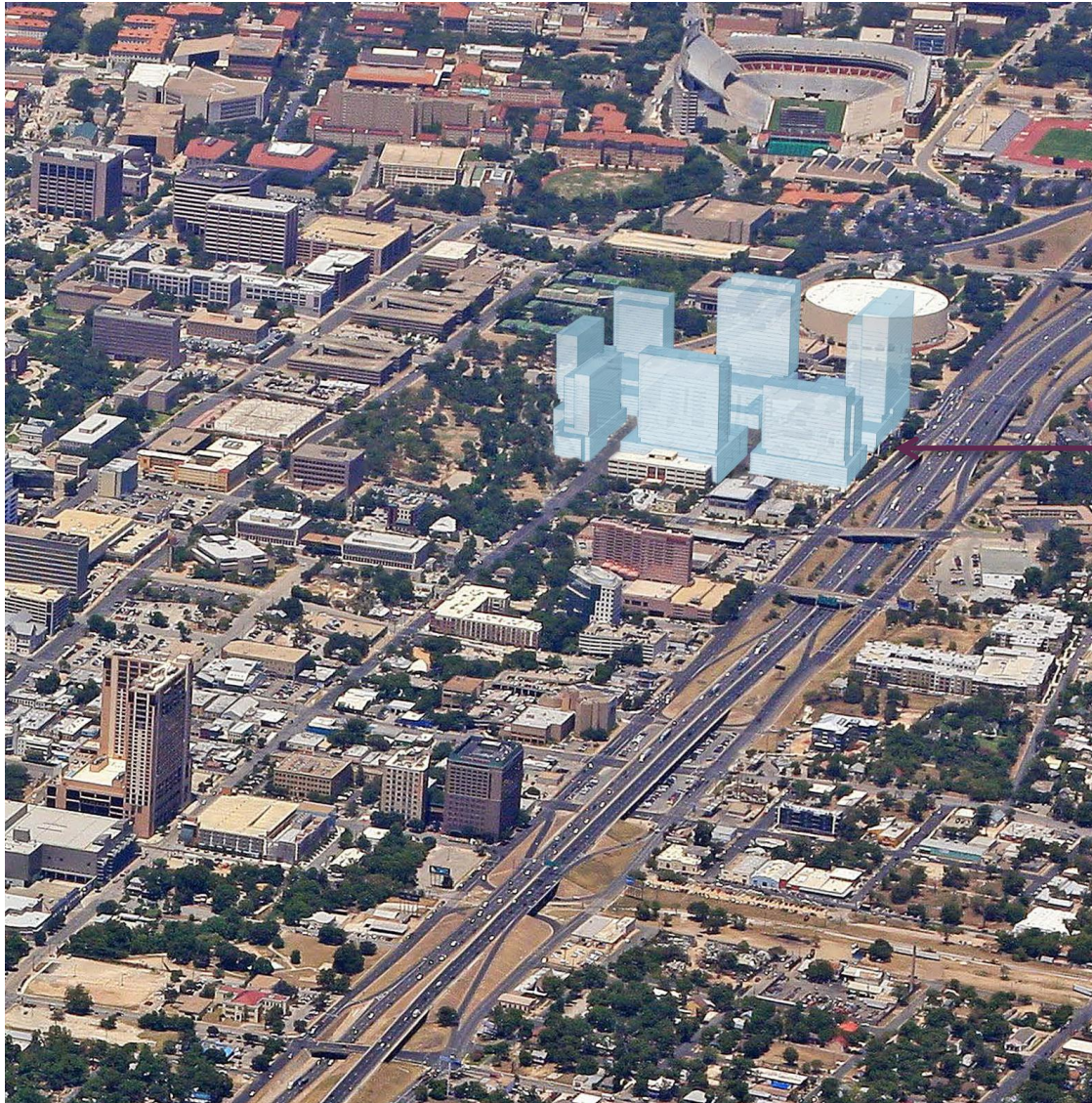
