#### **PROPOSAL**

To build a one and a half story addition to the side and rear of the original house.

The property is a contributing building within the Old West Austin National Register Historic District.

#### PROJECT SPECIFICATIONS


Build a one and a half story addition to the south and west of the original building. The new addition will share the façade and roof line of the original building. The addition be painted brick to match the existing house and will have window openings designed to match the existing windows in the house. The existing dormer on the house will be enlarged and the bay roof will change to a shed roof. The windows will be casement style windows. On the south façade two multi-panel garage doors will be installed in the addition. Another addition on the west façade will be installed. This will also match the rest of the house in siding material and style.

#### STANDARDS FOR REVIEW

The house is a contributing to the Old West Austin National Register Historic District, which has no specific design guidelines for additions. General design principles for historic districts encourage additions to the rear of the house with scale, massing, materials, and fenestration patterns complementing the house and other contributing houses within the district.

### STAFF RECOMMENDATION

Approve as proposed. The applicants have designed an addition with is sensitive to the style of the original building and are largely keeping the original building intact. While the large addition is not on the rear of the house, the style and architecture of the addition blends in well with the original style house and keeps the original house intact.
