RECOMMENDATIONS TO CITY COUNCIL

 On August 12, 2014, the CDC recommended that City Council add language to a city ordinance (Chapter 5-1 of City code) prohibiting discrimination in housing based on source of tenant's income.

On September 9, 2014, the CDC recommended the inclusion or retention of affordable housing incentives, including density bonuses and vertical mixed use zoning, in the CodeNEXT land development code updates.

• <u>S.M.A.R.T. Housing Resolution 20140410-026 – Recommendation 20140909-04c</u> On September 9, 2014, the CDC recommended approval of staff recommendations for S.M.A.R.T. Housing Transportation Criteria Code Amendment (City Council Resolution 20140410-026) and several next steps for staff to take to strengthen the transit orientation of S.M.A.R.T. Housing projects.

• <u>Cesar Chavez Foundation Partnership with Austin Housing Finance</u> Corporation – Recommendation 20141014-04a

On October 14, 2014, the CDC supported the proposed development of 1034 Clayton Lane and proposed partnership between Cesar Chavez Foundation and Austin Housing Finance Corporation.

• Change Responsible Organization for St. John Neighborhood Election of CDC Representative – Recommendation 20141014-05d

On October 14, 2014, the CDC supported the proposal to change the St. John neighborhood's responsible organization for nomination/election of CDC commissioner from St. John Advisory Board to St. John Neighborhood Association.

• Micro Unit Code Amendment – Recommendation 20141209-04b

On December 9, 2014, the CDC supported City Council's second reading language on proposed micro unit density bonus program (Council Resolution 20140327-040) with additional conditions regarding affordability requirements and source of income discrimination protection.

The CDC will continue to fulfill its core mission "to advise the Council in the development and implementation of programs designed to serve the poor and the community at large with emphasis of federally funded programs."

The CDC's goals and objectives for 2015 also correspond to one of Imagine Austin's Guiding Principles to "develop as an affordable and healthy community." This also includes the sixth Imagine Austin Priority Program: "household affordability throughout Austin."

Some areas where the CDC will continue to work are:

CITY POLICY/PROGRAM AREAS

- <u>Preservation of low- and moderate-income housing</u>. Continue to work with stakeholders, non-profits, and other organizations to ensure the preservation of low- and moderate-income housing remains a City priority.
- <u>Image Austin Comprehensive Plan</u>. Continue to receive briefings, monitor the plan, and complete work as directed by Council.
- <u>CodeNEXT.</u> Continue to work with the City to ensure that affordable housing
 incentives and policies are given consideration in land development code update
 process.
- <u>Planned Unit Developments.</u> Continue to monitor and review revisions in the development of PUDs so that they include input for opportunities to include lowincome housing.
- <u>Transit Oriented Districts.</u> Continue to monitor the development of TODs around Austin for opportunities to build low-income housing.

- <u>Vertical Mixed Use.</u> Continue to monitor the density bonus so that the correct amount of affordable housing is created.
- <u>Food Deserts.</u> The Neighborhood Centers Working Group will continue to work with EGRSO and HHSD to bring ideas and recommendations to the full CDC for consideration.
- Rental Registry. Continue to monitor the implementation of the pilot program.
 Continue to work with Code Compliance and others to develop a strategic policy for ensuring low- and moderate-income housing is maintained and remains safe for residents.
- <u>Tenant Relocation Policy</u>. Continue to work with the City, stakeholders, non-profits and others to develop a tenant relocation policy that ensures low-income residents that must relocate are given the needed resources and help to establish themselves in a new home.

CITY PLANNING INITIATIVES

- <u>Downtown Austin Plan.</u> Continue to receive briefings, monitor the plan, and complete work as directed by Council.
- <u>University Neighborhood Overlay (UNO)</u>. Continue to work with the Planning Commission to forward recommendations as directed by Council.
- <u>East Riverside Corridor Plan.</u> The CDC will continue to monitor and participate in the development on this corridor plan especially as it pertains to the development of affordable housing.
- <u>Holly Good Neighbor Program.</u> Continue to work on the charge to discuss the future funding of the Holly Good Neighbor Program, how funds might be reallocated; and how to educated residents about the program.
- <u>Rainey Street Subdistrict</u>. Continue to work to initiate amendments to the City Code that are necessary to ensure affordable housing in the Rainey Street Subdistrict.
- <u>Housing Sighting Policy and Geographic Dispersion</u>. The CDC will continue to work on this issue as directed by Council.
- <u>Community Land Trusts.</u> The CDC will continue to monitor legislation for any changes in the creation of CLTs, and monitor the development of CLTs in Austin.
- <u>Homestead Preservation Districts.</u> The CDC will continue to monitor the impact of HB 3350 for any changes in the creation of CLTs, and monitor the development of CLTs in Austin.
