D. ITEMS FOR COMMISSION'S REVIEW AND RECOMMENDATION FOR APPROVAL TO CITY COUNCIL

1. Recommend approval to authorize a construction contract with **FACILITIES REHABILITATION, INC**. (MH 94.03%) for the Barrington Way Force Main Reroute and Gravity System Upgrade project in the amount of \$1,592,434 plus a \$79,622 contingency, for a total contract amount not to exceed \$1,672,056. Kevin Koeller and Yvonne Gil addressed the Commissioners questions and concerns. Item passed on Commissioner Gray's motion and Commissioner Moriarty's second on a 6-0-1-0 vote with Commissioner Lee recusing. Commissioner Lee's firm is a sub consultant to the design engineer. 2. Recommend approval of a resolution consenting to the annexation of 17.89 acres into the Travis County Water Control and Improvement District 10 ("WCID #10") for the provision of water service. Bart Jennings addressed the Commissioners questions and concerns. Item passed unanimously on Commissioner Lee's motion and Commissioner Gray's second with a 7-0 vote.
