#### Subject

Authorize award and execution of a 36-month contract with ONLINE COMPUTER LIBRARY CENTER, INC., for a subscription to access the database of bibliographic records in Machine Readable Cataloging format at the Austin Public Library in an amount not to exceed \$267,276, with three 12-month extension options in an amount not to exceed \$89,092 per extension option, for a total contract amount not to exceed \$534,552.

# Amount and Source of Funding

Funding in the amount of \$29,697 is available in the Fiscal Year 2014-2015 Operating Budget of the Austin Public Library. Funding the remaining 32-months of the original contract period and extension options are contingent upon available Operating funding in future budgets.

The contract is to provide automated online cataloging database services applied to circulating and reference materials added to the collection and library catalog of the Austin Public Library (APL). The acquisition of a variety of resources in various media formats for the APL include in-house cataloging and processing as well as cataloging and processing for shelf-ready drop ship delivery by vendors. The APL consists of the John Henry Faulk Central Library, the Austin History Center, and twenty branch libraries. The City broke ground on a new central library which is estimated to open in 2016.

All library circulating and reference resources added to the library collection are cataloged to facilitate the management and checkout of holdings for staff and library customers. Cataloging of materials is a standard practice that continues to evolve in the Library industry. Rather than libraries individually deciding on the classification and creation of bibliographic records for each acquired title, and in order to provide consistency of library resource records on a global basis, librarians nationally and internationally use a universal cataloging system that follows the Library of Congress (LOC) Dewey Decimal System standards for physical and digital media.

This contract provides compliance with LOC standards and shares online cataloging services that saves the staff from individually classifying the many thousands of titles received annually. To find specific items in the APL, users search for the location and Dewey Decimal Number in the online public access catalog. This agreement will allow APL catalogers to obtain, maintain and manage records into the library's online catalog for existing and new library materials. This agreement will also allow suppliers that contract with APL to obtain record information for the cataloging of shelf-ready drop ship deliveries to library locations.

The current contract for this cataloging database service expires July 1, 2015. Without a contract the library will be forced to manually catalog the materials.
