Authorize award, negotiation, and execution of a contract with ALTURA SOLUTIONS, L.P. to provide an Americans with Disabilities Act self-assessment and develop a system-wide transition plan for Parks and Recreation Department properties in an amount not to exceed \$240,300.

Amount and Source of Funding

Funding in the amount of \$75,000 is available in the Fiscal Year 2014-15 Capital Budget of the Parks and Recreation Department. Funding in the amount of \$165,300 is available in the Fiscal Year 2014-15 Parks and Recreation Operating Budget.

Additional Backup Information			

The contract is to conduct and develop an Americans with Disabilities Act (ADA) Parks & Facilities self-assessment and system-wide transition plan for all Parks and Recreation Department (PARD) properties. As a Title II public agency, PARD is required under both the ADA and State of Texas Accessibility Standard laws to provide facilities and services that are accessible to park patrons. The ADA requires that public agencies conduct a self-assessment to quantify their backlog of accessibility shortcomings and prepare a long-term transition plan to guide the process of facility repair, renovation or replacement. PARD's initial transition plan was prepared over 15 years ago as part of a broader City initiative.

The contractor will engage PARD staff, the Human Resources Department's ADA Office, and the Mayor's Committee for People with Disabilities, which acts as an advisory body to Council and the City Manager regarding problems affecting persons with disabilities in the Austin area.

If Council does not approve the contract, PARD will not be able to address its accessibility shortcomings in a systemic fashion and will have to continue to address them in a potentially more costly ad hoc manner.
