## Subject

Authorize award and execution of Amendment No. 6 to a contract with STRYKER CORPORATION to purchase additional equipment for the Emergency Medical Services Department, increase the current contract authorization by \$125,000, and increase the remaining extension option by an additional \$125,000 to \$975,000, for a total contract amount not to exceed \$3,959,849.

# Amount and Source of Funding

Funding in the amount of \$125,000 is available in the Fiscal Year 2014-2015 Operating Budget of the Emergency Medical Services Department. Funding for the remaining extension option is contingent upon available funding in future budgets.

	Additional Backup Information	

The amendment will provide the Emergency Medical Services Department (EMS) with additional funding to purchase Stryker Powerload equipment and services. Each ambulance in the EMS fleet is currently equipped with a Stryker Power-Pro XT. All field staff are trained on this model and replacement equipment and supplies must be compatible with the existing equipment to ensure interoperability and a uniform standard of practice. This contract currently provides powered ambulance lift systems, powered ambulance stretchers, stair chairs, accessories, and service for EMS. Since 2014, ambulances have been retrofitted with the Stryker Powerload cot fastener system lifts. This includes the purchase and installation of Powerload compatible ambulance cots and related accessories. Currently, 35 of the 87 ambulances have been upgraded with the Powerload systems. There are seven ambulances currently in production and scheduled to receive the Powerload systems which will result in all of the front-line ambulances being upgraded. The expected delivery of additional Sprinter Ambulances (utilized for Special Events) and other required service and maintenance needs are the reason for this amendment.

Powered ambulance stretchers are mobile beds that EMS patients are secured to during transportation to a medical facility. Upon arrival at the hospital, the patient is then moved via the stretcher from the ambulance into the hospital emergency room.

The original purchase of the Stryker-brand ambulance stretchers was the result of a competitive solicitation held in 2005.

This contract was approved by City Council in 2011 for a 36-month base period in the amount of \$1,102,849 with three extension options for a total contract amount not to exceed \$2,570,741. In August 2014, an amendment Request for Council Action (RCA) was brought to Council to increase the extension options. The amount of the RCA did not account for the original amount of the extension options. An RCA was brought back to Council and approved in November 2014 to correct the authorized amount of the extension options. This RCA is to approve an increase to the current contract and the remaining extension option for a final contract value of \$3,959,849.
