## Subject

Authorize award and execution of a 60-month revenue contract with ALLEN CLICK to provide the cutting, baling, and sale of hay, and the harvest and sale of pecans for Austin Water for an estimated revenue of \$305,000, with one 60-month extension option with an estimated revenue of \$305,000, for a total estimated revenue amount of \$610,000.

## Amount and Source of Funding

An estimated revenue of \$30,500 shall be applied to the Fiscal Year 2014 – 2015 Operating Budget of Austin Water. Funding of the remaining 56-months of the initial contract period are contingent upon available funding in future budgets.

The contract will provide for the cutting, baling, and sale of hay from approximately 528 acres of farm acreage and the harvest and sale of pecans from an approximately 10 acre pecan tree orchard. The hay will be cut approximately four times a year and the pecans will be harvested annually. This contract is required because the hay that grows at Hornsby Bend assists Austin Water in removing nitrogen and phosphorus from the soil that is treated with biosolids.
