## **ORDINANCE NO. 20150618-077**

AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND REQUIREMENTS UNDER CITY CODE CHAPTER 14-8, AND AUTHORIZING CERTAIN OTHER FEES AND REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED 2015 JUNETEENTH PARADE AND CELEBRATION TO BE HELD ON JUNE 20, 2015.
