### **A. CALL TO ORDER**

Chair Gray called the meeting to order at 6:03pm.

### **C. APPROVAL OF MINUTES**

The April 8, 2015 WWW Commission regular meeting minutes were approved on Commissioner Lee's motion and Commissioner Fishbeck's second on a 5-0-0-2 vote with Commissioner Ohueri and Moriarty absent.

### **D. ITEMS FOR COMMISSION'S REVIEW AND RECOMMENDATION FOR APPROVAL TO CITY COUNCIL**

1. Recommend approval to award and execute a 24-month contract with **AUSTIN WHITE LIME COMPANY**, Austin, TX for the supply of quicklime for Austin Water in an amount not to exceed, \$6,858,000, with two 12-month extension options in an amount not to exceed \$3,429,000 per extension option, for a total contract amount not to exceed \$13,716,000. **Item passed on Commissioner Fishbeck's motion and Commissioner Castleberry's second on a 5-0-0-2 vote with Commissioner Moriarty and Ohueri absent.**

2. Recommend approval to award and execute a 36-month service contract with **ALLIED FENCE & SECURITY** to provide fencing repair and installation in an amount not to exceed \$2,831,296, with three 12-month extension options in an amount not to exceed \$943,765 per extension option, for a total contract amount not to exceed \$5,662,592. This is a multi-department contract. Austin Water's portion of the requested authorization is \$100,000. **Item passed on Commissioner Fishbeck's motion and Commissioner Castleberry's second on a 5-0-0-2 vote with Commissioner Moriarty and Ohueri absent.**
3. Recommend approval to award and execute a 12-month service contract through the State of Texas Department of Information Resources contract with **VERIZON WIRELESS, AT&T MOBILITY and T-MOBILE USA** for wireless communication services and equipment in an amount not to exceed \$2,500,000 each and combined, with four 12-month extension options in an amount each and combined not to exceed \$2,575,000 for the first extension option, \$2,652,250 for the second extension option, \$2,731,818 for the third extension option, and \$2,813,772 for the fourth extension option, for a total contract amount not to exceed \$13,272,840 each and combined. Austin Water's portion of the requested authorization is \$350,000. **Item passed on Commissioner Fishbeck's motion and Commissioner Castleberry's second on a 5-0-0-2 vote with Commissioner Moriarty and Ohueri absent.**
4. Recommend approval to award and execute a 12-month requirements service contract with **PURE TECHNOLOGIES US, INC.**, Columbia, MD for non-destructive leak and condition assessment of large diameter transmission mains for Austin Water in an amount not to exceed \$685,508, with two 12-month extension options in an amount not to exceed \$685,508 per extension option, for a total contract amount not to exceed \$2,056,524. **Item passed on Commissioner Fishbeck's motion and Commissioner Castleberry's second on a 5-0-0-2 vote with Commissioner Moriarty and Ohueri absent.**
5. Recommend approval to execute an amendment to the cost reimbursement agreement with **CENTURY LAND HOLDINGS II, LLC.** to increase the amount of the City's cost reimbursement by \$646,807.24 for a total amount not to exceed \$2,778,848.43. **Colleen Kirk addressed the Commissioners questions and concerns. Item passed on Commissioner Castleberry's motion and Commissioner Lee's second on a 4-0-1-2 vote. Commissioner Clark abstained and Commissioners Moriarty and Ohueri were absent.**
