Additional Backup Information						
The Texas Department of State Health Services (TDSHS) allocates federal pass-through funds for the STD/HIV Grant to assist the City of Austin Health and Human Services Department (HHSD) to provide clinical and preventive services to the community to reduce the incidence of sexually transmitted diseases (STDs). Program objectives focus on the reduction/elimination of syphilis and the prevention and reduction of immunodeficiency virus (HIV), gonorrhea, chlamydia and other STDs within Travis County. HHSD was granted an additional \$55,077 for Fiscal Year 2014-2015 because the TDSHS is adding four months to the grant term, amending the current grant term September 1, 2014 through August 31, 2015 to September 1, 2014 through December 31, 2015. The additional funding brings the grant award to \$405,077, and will help improve quality of life, and reduce the years of potential life lost due to preventable conditions. The General Fund will not be required to contribute additional funds beyond those currently budgeted to this grant.						
When the grant funds expire, the HHSD's need for continuing funding will be evaluated and may be denied.
