The contract will provide unarmed security guard services for numerous City facilities within the Austin Convention Center Department (ACCD), Austin Resource Recovery Department (ARR), Aviation, Building Services Department (BSD), Municipal Court, Downtown Community Court, Library Department, Watershed Protection Department(WPD) and the Health and Human Services Department. This contract includes routine security guard services, special-event services, crowd control, and other security-related services. The contract will also include physical inspections and vehicle patrols, documenting and reporting activities and incidents, and maintaining facility logs. For the duration of the contract, the contractor will own the vehicles to be used under this contract and will hold the title and registration for each vehicle. As such, the contractor is solely responsible for the maintenance of the vehicles and keeping the vehicles in good operating condition, and for ensuring all insurance and liability coverages are current for each vehicle.

The proposals were evaluated by a team comprised of individuals from ACCD, ARR, Library, and BSD with expertise in security guard services. The panel members recommended US Security Associates, Inc. as the best proposer based on: program plan, concept and solutions, background, qualifications, prior experience, retention plan, cost and interview results.

This contract will replace the current contract for security guard services which will expire October 23, 2015, with no contract extension options remaining. Therefore, the timely execution of this contract is critical to ensure a continuation of guard services provided at the various City facilities. Adequate time is needed to transition to a new contractor.

This request allows for the development of a contract with a qualified offeror selected by Council. If the City is unable to negotiate a satisfactory contract with the selected offeror, negotiations will cease with that provider. Staff will return to Council so that another qualified offeror may be selected, authorizing contract negotiations with this provider.
