TEMPO 2015 ART IN PUBLIC PLACES PROJECT

PROJECT SUMMARY

The City of Austin's Art in Public Places (AIPP) program of the Cultural Arts Division, Economic Development Department seeks proposal from professional visual artists or artist's team to design, fabricate and install site-specific, short-term artwork or time based performances in designated areas of Austin, including; parkland spaces, libraries, street and bridges, right of way and other sites to be determined. The intent for the temporary public art is to cultivate curiosity, spark imagination and engage the community in a meaningful dialogue about public art and foster work by local artists and cultivate tourism.

The City of Austin requests proposals from professional artists and designers who live and work in Williamson, Travis, Bastrop, Caldwell, Hays, Burnet and Blanco counties are eligible to apply.

Multiple commissions will be awarded. The budget for artwork ranges from \$3,000 to \$10,000 for each commissioned work.

ARTWORK GOALS

The goal of the Art in Public Places Program is to commission works of art and art projects of redeeming quality that advance the public's understanding of visual art and enhance the aesthetic quality of public places. Temporary public art plays an important role in attracting new and emerging artist to participate in the city's public art program, enriches the civic dialogue, and engages public space in a unique way. The TEMPO program would allow the artist to explore a range of themes suitable for the outdoor environment and provide the opportunity for innovative, thought-provoking artwork that impacts the way people experience their environment.

Goals:

- Expose citizens to contemporary artworks by local artists;
- Foster engagement between artist, artwork and the community;
- Link artists with resources and city assistance to develop skills and experience;
- Facilitate public discussion, civic dialogue, and collaborative partnering for programming;
- Promote new interest and increased participation in, and focus on, public art;
- Cultivate tourism activity around the arts in Austin.

BUDGET

A minimum amount of \$3000 and a maximum amount of \$10,000 is available for each public art project. Though multiple commissions will be awarded, there is no set number of commissions.

SELECTION PROCESS

A Request for Proposals (RFP) was released on Thursday, March 5, 2015 to professional visual artists and artist teams, at least 18 years of age, who live or work in Williamson, Travis, Bastrop, Caldwell, Hays, Burnet and Blanco counties. Deadline for the applications was Friday, April 24, 2015 at 5 pm.

Two Artist Information Meetings were held on March 26, 2015 from 5:30 – 6:30 pm CST and April 9, 2015 from 5:30 – 6:30 pm CST at the Cultural Arts Division Training Room, presented by AIPP staff.

On Monday, April 27, 2015, the Selection Panel reviewed 56 completed applications and recommended 11 proposals. The recommended artists are: Olivia Martin Moore, Ethan Azarian, Melissa Borrell & Hanna Lupico, Jennifer Chenoweth & Dorothy Johnson, Juan Deleon, Yareth Fernandez, David Goujon, Yuliya Lanina, Annelize Machado, Eto Otitigbe, and George Sabra.

ART IN PUBLIC PLACES PANEL (Presentation)

On September 8, 2014, Meghan Wells presented the revised policy for the temporary art program (TEMPO) based on funding by Hotel Occupancy Tax funds to be approved each year by City Council. The guidelines include the promotion of tourism and availability to people visiting Austin. Panel Member Hammonds made a motion to approve the TEMPO program policy. Panel Member Walker seconded. Motion passed unanimously 7-0-0.

AUSTIN ARTS COMMISSION (Presentation)

On September 15, 2014, Commissioner Flores made a motion to approve the revised TEMPO Program Policy. Commissioner Willenzik seconded the motion. Motion approved (7-0-0).

ART IN PUBLIC PLACES PANEL (Prospectus)

On January 12, 2015 the AIPP Panel approved the Prospectus for the TEMPO Project. Panel member Hammonds made a motion to approve the Prospectus. Panel Member Walker seconded. Motion passed (6-0-1). Panel Members Frank left early.

AUSTIN ARTS COMMISSION (Prospectus)

On January 26, 2015, Commissioner Tinnon made a motion to approve the AIPP Panel's recommendation for the prospectus and selection panel for the TEMPO project. Commissioner Auerbach seconded the motion. Motion approved (7-0-0).

ART IN PUBLIC PLACES PANEL (Process)

On May 4, 2015, Anna Bradley presented the Selection Process Recommendations for the TEMPO 2015 program. Eleven proposals were selected out of 56 applications. Each proposal was reviewed; discussion ensued regarding proposed sites, proposed budgets, proposed fabrication methods and costs, how the artwork proposals respond to the program goals and goal for geographic distribution of artwork through the TEMPO 2015 program.

Specific concerns about several of the recommended proposals were discussed. Panel Member Little made a motion to approve the Selection Process Recommendations for TEMPO 2015, with the expectation that staff would convey the concerns cited by the Selection Panel and the AIPP Panel, to artists Sabra, Otitigbe, and Lanina, which may result in revisions to artists' sites and/or designs. Panel Member McCray seconded. Motion passed 6-0-0. Panel Member Frank was absent

AUSTIN ARTS COMMISSION (Process)

On May 18, 2015, Commissioner Flores made a motion to approve the Selection Process Recommendations for TEMPO 2015 AIPP project. Commissioner Mok seconded the motion Commissioner Auerback voted against. Motion approved (6-1-0).
