

**ORDINANCE NO. 20150806-039**

**AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64(D) TO ESTABLISH A MAXIMUM SPEED LIMIT OF 40 MILES PER HOUR ON SEGMENTS OF THE LAKES BOULEVARD.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** City Code Section 12-4-64(D) (*Table of Speed Limits*) is amended to add:

The Lakes Boulevard from IH 35 (North) East Frontage Road to the Austin city limit. (40 MPH).

The Lakes Boulevard from 0.23 miles north of Howard Lane to the Austin city limit. (40 MPH).

**PART 2.** The amendments made in this ordinance are based on the results of a traffic engineering investigation, or "speed study," attached as Exhibit "A".

**PART 3.** The amendments made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.

**PART 4.** This ordinance takes effect on August 17, 2015.



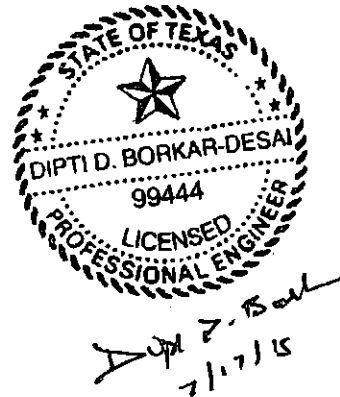

**Subject:** SPEED ZONE INVESTIGATION

**Location:** The Lakes Boulevard – IH 35 (North) East Frontage Road to Austin City Limit (to the east) and 0.23 miles north of Howard Lane to Austin City Limit (to the north).

Date(s) of Previous Investigation: N/A

A Traffic Engineering Investigation has been conducted by this Division to determine the posted speed limit on The Lakes Boulevard from IH 35 (North) East Frontage Road to Austin City Limit and 0.23 miles north of Howard Lane to Austin City Limit in accordance with the Texas Procedures for Establishing Speed Zones, 2006 (see Figure 1).

#### General Conditions:

The Lakes Boulevard functions as a four-lane collector from IH 35 (North) East Frontage Road to Austin City Limit (to the east) and is partially divided with a median at its approach to IH 35 (North) East Frontage Road. It functions as a four-lane undivided collector from 0.23 miles north of Howard Lane to Austin City Limit (to the north). The adjoining property is commercial/industrial and residential with large apartment complexes; and all driveways accessing The Lakes Boulevard. There are sidewalks on both sides of road from Howard Lane to IH 35 (North) East Frontage Road.

Additionally, the section of The Lakes Boulevard from Howard Lane to 0.23 mi. northward to the Austin City Limits which is under the jurisdiction of Travis County has a posted speed limit of 40 Miles per Hour (MPH).

### Speed / Volume Data Collected:

Speed and volume data were collected in April 2015 to determine the appropriate posted speed limit for the study segment.

### Recommendation

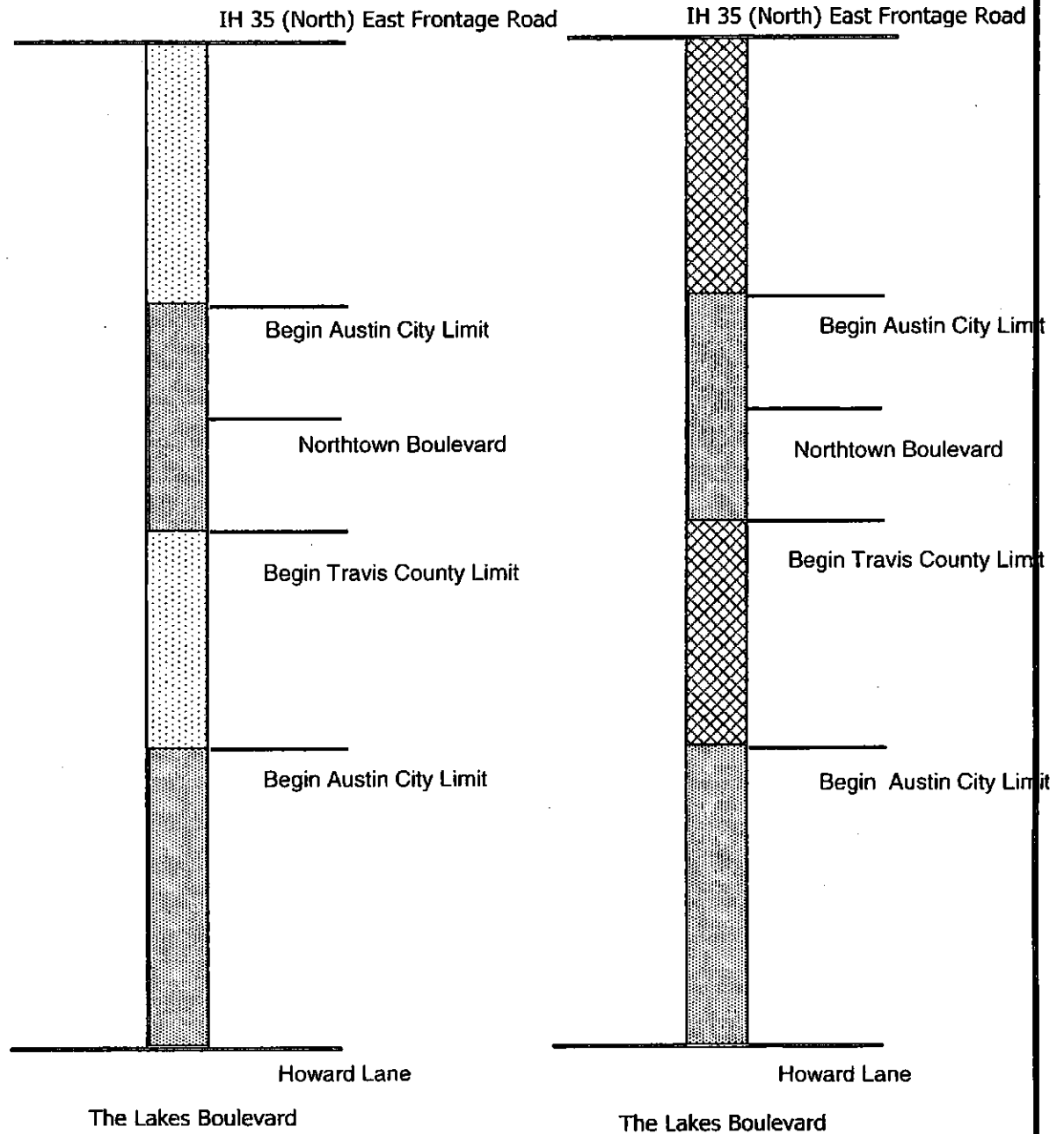
The analysis of the speed data indicates that the 85<sup>th</sup> percentile speed along The Lakes Boulevard is between 44.5 and 46.6 mph in the section from IH 35 (North) East Frontage Road to Austin City Limit (to the east). The 85<sup>th</sup> percentile speed is between 45.9 and 48.9 mph in the section 0.23 miles north of Howard Lane to Austin City Limit (to the north).

Due to the functionality of The Lakes Boulevard as a collector street with residential development (large apartment complexes) and to maintain a consistent speed limit with the segment under Travis County jurisdiction, a speed limit greater than 40 mph is not recommended.

Based on the analysis of this information, it is my engineering judgment that the speed limit on The Lakes Boulevard from IH 35 (North) East Frontage to Austin City Limit and 0.23 miles north of Howard Lane to Austin City Limit should be 40 miles per hour.
