The contract will provide smoke testing of the sanitary sewer collection system pipes in the Harper's Branch and Fort Lower wastewater drainage basins for Austin Water. Smoke testing forces smoke-filled air through a sanitary sewer line. The smoke under pressure will fill the main line plus any connections and follow the path of any leak to the ground surface, quickly revealing the source of the problem. Only enough force to overcome atmospheric pressure is required.

The smoke that is used is endorsed by the Environmental Protection Agency and has been safely used for more than 20 years. The "smoke" is not true smoke, but rather a mist containing a large percentage of atmospheric moisture that is highly visible at low concentrations. It is not harmful to health, will not leave a stain, and will disappear rapidly without leaving odor.
