The contract is to provide water quality monitoring, which will be conducted by at-risk students. Colorado River Watch Foundation dba Austin Youth River Watch (AYRW) is a non-profit service organization that works with the Lower Colorado River Authority (LCRA) and their Colorado River Watch Network program to train at-risk students					

The AYRW program combines environmental education with drop-out prevention for at-risk high school students. It is a multi-year, after-school and summer program that combines peer mentoring and intensive environmental education.

in water quality monitoring methods.

CRWN provides the equipment and chemicals required for students to collect, analyze and publish water-quality data from Austin area streams and rivers. They report their data to local and state-wide agencies, which has been used by scientists, policymakers, and environmentalists to improve the management and protection of our local waterways. It also creates an early warning system that alerts the City and LCRA to potential water quality threats. AYRW proposes to assist the Watershed Protection Department (WPD) by expanding the program to include the investigation of the source of fecal bacteria contamination for creek reaches designed by WPD staff, as well as by the adoption of specific areas for riparian restoration consistent with the goals of WPD.

AYRW was established with initial funding provided by the City and LCRA and continual funding will include the City, governmental support, grants from private foundations, contributions from partnering corporations, and many donations from individuals. The value of this program was recognized specifically by City Council Resolution 20140807-099.

The current contract expired July 12, 2015 and without a contract, water-quality in the Austin area streams and rivers could be threatened and early warning system that alert the City and LCRA to potential water quality threats would be delayed.
