The contract with Hartwell Environmental Corporation is for the purchase of three 15 HP and two 20 HP Seepex Progressive Cavity Pumps for the Hornsby Bend Wastewater Treatment Plant. These pumps will be used for sludge transfer at the thickener building to supply the gravity belt thickeners and move sludge from the gravity belt thickeners to the digesters.
