Chapter 26 of the Texas Parks and Wildlife Code provides that the use of parkland for non-park purposes may be approved upon a finding that there is no feasible and prudent alternative to the use of this land.							
The Austin Transportation Department sponsors the application for an above-grade walkway over Red River Street between the Austin Convention Center and the Fairmont Hotel. Pedestrian access on the eastern side of the Convention Center is limited to an at-grade cross-walk at the corner of Red River and Cesar Chavez. Pedestrian access along Cesar Chavez is constrained by a bridge with a less-than-five-foot walkway from curb top to the bridge railing. The existing sidewalk is sub-standard to meet future use. The hotel will have 1,000 rooms and 100,000 square feet of conference space. There is a potential for the space to be used in conjunction with the convention center, requiring large volumes of pedestrians needing to get back and forth between the facilities in limited time periods.							

The existing connection is not sufficient to support that activity.

The proposed above ground walkway will create a pedestrian walkway that is Americans with Disabilities Act (ADA) accessible with sufficient capacity to serve the needs of both facilities. The hotel will tie into Waller Creek Trail and Palm Park, expanding the usefulness of the facility.

The proposed use of parkland supports several City priority programs and policy directives set forth in the Imagine Austin Comprehensive Plan by investing in a compact and connected pedestrian network, as well as by creating places and access to adjacent parkland.

The Austin Transportation Department requests the use of the parkland to improve mobility and safe access for Convention Center guests and pedestrians across the Red River right-of-way.

Approval of the use of parkland is made on the condition that all restoration is completed in accordance with the Standard Specifications and Construction Standards of the City of Austin and the Parks and Recreation Department's "Construction in Parks Specifications". The Transportation Department is required to pay all costs associated with the restoration and tree mitigation as part of the site restoration process.

There is no feasible and prudent alternative to the use of the dedicated parkland, which includes all reasonable planning to minimize harm to such lands. The dates of public notification in the *Austin American-Statesman* were July 26, August 2 and 9, 2015.
