PROPOSAL

Demolish a ca. 1902 house.

ARCHITECTURE

One-story, wing-and-gable plan frame house with a partial-width independent shed-roofed porch on plain wood posts; non-historic replacement windows in the front.

RESEARCH

The house was built around 1902 for Walter and Ida Bonugli, who lived here until around 1934. Walter Bonugli was the son of Michael and Mary Bonugli, prominent neighborhood grocers in this section of East Austin for many years, and it is very possible that Michael and Mary Bonugli built this house, as they lived at 1201 E. 1st Street, which was demolished around 1921 for a commercial building (which housed several grocery stores, including the East Austin A&P Grocery Store in the late 1920s and early 1930s). Walter Bonugli was in the soft drink business, starting off as a bottle washer at the Austin Ice and Bottling Company, then working at the Star Bottling Works, where he was a bottler and later became a foreman, and finally superintendent and salesman. Around 1915, he went to work as a salesman for the Austin Coca-Cola Bottling Company, then around 1919, he became a salesman for the meat packing company, Swift and Company, a position he held for the remainder of his tenancy in this house. Around 1934, the Bonuglis moved to 700 Landon Lane, where they lived for the rest of their lives.

From the mid-1930s until around 1946, the house was a rental property. The tenants included a couple where the wife worked as a saleslady for Scarbrough's, Austin's leading downtown department store, the proprietor of a meat market, a plumber, and a serviceman for the Texas Public Service Company (the precursor to Southern Union Gas). Ricardo and Seferina Guerrero are listed as the owners of the house in the 1947 city directory; he was a mechanic, who died in 1948. Seferina Guerrero stayed in the house until around 1950, but it appears that the house remained in the Guerrero family, who rented it out for many years thereafter. Later tenants of the house included the proprietor of a service station, and city employees.


STAFF COMMENTS

The house is not listed in any City survey. The house has suffered numerous architectural modifications, including unsympathetic alterations to the front façade, which include the removal of all bays across the wing section of the front of the house. The applicant is seeking to remove this house to build a driveway and parking lot for the adjacent commercial building at 1201-03 E. Cesar Chavez Street.

STAFF RECOMMENDATION

Release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. While the house has a very interesting history and is an important part of the context of the settlement of East Austin, it has undergone such radical architectural changes that it cannot qualify as a historic landmark.

BIOGRAPHICAL NOTES:

Walter and Ida Bonugli (ca. 1902 – ca. 1934)

The 1900 U.S. Census shows Walter Bonugli as the 20-year old son of Michael and Mary Boungli, who lived at 1201 E. 1st Street. Michael Bonugli had been born in Italy, and was a grocer. He had immigrated to the United States in 1872. Mary Bonugli had been born in Texas, and had no occupation listed. Walter Bonugli was a clerk in a grocery store. His younger brother, Louis, 17, was a day laborer.

The 1910 U.S. Census shows Walter and Ida Bonugli at this address. Both were 30 years old, and both had been born in Texas. Walter Bonugli was a driver for a soda company. Ida Bonugli had no occupation listed. They had a daughter, Ione, 7, who had been born in Texas, as well as a boarder, Fernie Byas, 9, who had been born in Texas.

His 1918 World War I draft registration card shows Walter William Bonugli living at this house, 1205 E. 1st Street. He was born July 24, 1879, and was the city salesman and truck driver for the Coca-Cola Bottling Company in Austin. He was of medium height and slender build with blue-green eyes and dark brown hair.

The 1920 U.S. Census shows Walter and Ida H. Bonugli as the owners of this house. Walter W. Bonugli was 40, and was a salesman for a packing house; Ida H. Bonugli was 42, and had no occupation listed; Their daughter, Ione M., was 16, and had no occupation listed.

The 1930 U.S. Census shows Walter and Ida Bonugli as the owners of this house, which was worth \$1,900. Walter Bonugli was a 50-year old salesman for a packing house. Ida Bonugli was 53, and had no occupation listed. They had 2 roomers: Fern Hudson, 27, an Oklahomaborn teacher; and Jessie Merriman, also 27, a New York-born teacher. Both women taught at the State School for the Deaf.

By 1940, Walter and Ida Bonugli were living at 700 Landon Lane, a house they owned, and which was worth \$4,500. Walter Bonugli was a traveling salesman for a wholesale meat packing company. Ida Bonugli had no occupation listed. They had no children living with them.

WALTER WILLIAM BONUGLI Walter William Bonugli, 81, of 700 Landon Lane, died in a local hospital Monday morning. He was a lifetime resident of Austin and as member of the Shettles Memorial Methodist Church. Before his retirement Bonugli was all salesman for Swift and Company and Coca-Cola Company. He is survived by his wife. Mrs. Ida Bonugli, Austin: one daughter, Mrs. E. W. Cartwright, Austin: one brother, Louie Bonugli, Austin: one grandchild and one great grandchild. Hiesler was 41, had been born in Texas, and was a natural gas pipe fitter. Annie L. Hiesler was also 41, had been born in Texas, and had no occupation listed. With them lived James J. Routon, a step-son, 24, who had been born in New Mexico, and was a soda dispenser at a drug store; Warren and Avanelle Routon, another stepson and his wife. Warren Routon was 26, had been born in Texas, and was a dairy products salesman; Avenelle Routon was 27, had been born in Texas, and had no occupation listed. They had a daughter, Shirley, 3. They had lived in Dallas in 1935. Martha Nunnelee, is listed as a stepdaughter; she was 14, and had been born in Texas. In addition, the household included Terrill Hiesler's mother, Sadie Gallamore, a 63-year old Texas-born widow with no occupation listed, who had lived in rural Travis County in 1935; and Terrill's sister, Thelma Graham, a 36-year old divorcee, who had been born in Texas, was a practical nurse in a private home; she had lived in Wilmar, California in 1935.
