- a) Healthy Food Finance, American Heart Association Postponed
- b) Neighborhood Food System Planning Pilot- Edwin Marty
  - An interdepartmental team looking at increasing mobility and access to healthy food in the Rundberg community.
  - Similar to Go Austin, Vamos Austin project. UT has evaluation tools developed and it's an incredible opportunity to use lessons learned from GAVA.
  - Why Rundberg? There are 3 neighborhood associations in Rundberg but the Health Department looked at the area as a whole and it was desirable, from their standpoint, to receive a grant. They hope to have more intentional community outreach on the front end, in the next project.
- c) Local and Healthy Food Procurement- Rose Jennings
  - Question: At what point would you bring in a stakeholder coalition?
    - i. Will be presenting to different community members as well as coordinating agencies to get their feedback for what standards could possibly be used.
    - Seems like case studies have lack of impact tracking. Can you speak to why this is? And how to design it into a process for Austin?
      - i. Happens with many interventions at a City level. Working w/ universities would be key to guide how evaluation happens. Los Angeles would come to Austin and help us implement here in Austin; they are required to share since it's Grant funded.
