| MBE/WBE: | <p>This cooperative contract will be awarded in compliance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. No subcontracting opportunities were identified; therefore, no goals were established for this contract.</p> |

The contract is for the purchase of automated external defibrillators (AEDs) and related supplies for the Public Safety Departments: Austin Fire Department (AFD), Austin Police Department and Austin Travis County Emergency Medical Services Department (EMS) and for numerous City facilities within the Austin Convention Center, Austin Public Library, Aviation Department, Austin Energy, Building Services Department, Fleet Department, Human Resources Department, Parks and Recreation Department, Austin Water, and Wireless Communications. AFD and EMS order AED units and supplies for use by emergency medical first-responder personnel. City departments order AED units and supplies for use in City facilities and designated public spaces.

Emergency first responders in Travis County (AFD, EMS, Travis County Sheriff's Office, and all volunteer fire departments) operate under the medical license of Dr. Paul R. Hinchey, Medical Director for the City and Travis County. Dr. Hinchey has authorized the use of Philips and Zoll AED units. AEDs require a physician serving as the medical oversight for the persons operating the devices in order to achieve compliance with U.S. Food and Drug Administration rules regarding the sale of restricted devices.

AEDs are critical medical devices for first responders and for our community when treating a patient experiencing a sudden cardiac arrest incident. Likewise, non-emergency personnel may use the portable AEDs to provide defibrillation and cardio pulmonary resuscitation to a cardiac arrest victim until emergency responders arrive.

Philips and Zoll AED units and supplies are available on the Heartsafe America, Inc. TXMAS Cooperative contract. Heartsafe America has offered the City a 42% discount off their price list, which is a deeper discount than the published price list at a 35% discount off Philips products. Heartsafe America has also offered the City a discount in the range of 3-11% off the Zoll price list.
