Parking - Due to a planned change from Art Gallery and Laundry Services to Medical Office in Suite Nos. 103 and 104, an additional six (6) parking spaces are required. In order to allow a local business (Cajun Pizza) to remain in Suite 111, a variance request is hereby submitted to reduce the number of required parking spaces by five (5) parking spaces (currently the development provides one additional parking space over the requirement). Currently, Suite Nos. 106 (2 spaces) and 107 (2 spaces) are vacant and unfinished; therefore, the impact of granting such a variance would be minimal on the overall parking. In the event the variance is rejected, the Owner would not be able to extend the current lease for Suite No. 111 and would reclassify the suite as general retail sales and services and lease the suite for such use.

Due to leasing issues, there are multiple vacant "shell" spaces within the development. In order to retain a local business in Suite No. 111, the variance is being sought.

Since the development not fully leased, the on-site parking lot is sufficient and the variance will not adversely impact adjacent property owners.

The vacant "shell" spaces within the project produce no traffic; therefore, there is sufficient parking for the development.

2. The granting of this variance will not result in the parking or loading of vehicles on public streets in such a manner as to interfere with the free flow of traffic of the streets because:

Due to the amount of vacant "shell" spaces within the development, the grant of this variance will not interfere with traffic on the streets.

3. The granting of this variance will not create a safety hazard or any other condition inconsistent with the objectives of this Ordinance because:

Adequate on-site parking will be available and the grant of this variance will not create a safety hazard.

4. The variance will run with the use or uses to which it pertains and shall not run with the site because:

Any future issuance of a certificate of occupancy for the presently vacant Suite Nos. 106 or 107 will require the parking to be re-evaluated. The site plan correction that will follow the approval of this variance will include a requirement for re-evaluation and, if not approved, the variance will terminate.

NOTE: The Board cannot grant a variance that would provide the applicant with a special privilege not enjoyed by others similarly situated or potentially similarly situated.
