



- Oakwood Cemetery Annex (1914), 1601 Comal Street
- Plummers Cemetery (c. 1898), 1150 Springdale Road
- Evergreen Cemetery (1926), 3304 East 12th Street
- Austin Memorial Park Cemetery (1927), 2800 Hancock Drive







# Planning Process

- Spring, 2012: PARB Working Group meetings to identify issues & concerns
- Summer, 2013: 6 meetings to develop Scope of Work
- Fall, 2013: Request for Proposals issued
- March, 2014: Contract with AmaTerra Environmental executed
- 2014-2015: 5 Community Meetings
  - April 30, 2014: Carver Branch Library
  - June 26, 2014: NW Recreation Center
  - August 23, 2014: Ruiz Branch Library
  - November 3, 2014: Zilker Botanical Garden
  - January 24, 2015: Carver Branch Library
- Jan. 23-Mar. 9, 2015: Draft Master Plan Posted for Community Review
- Early April, 2015: Revised draft posted for Boards, Commissions & Council











**Evergreen Cemetery (1926)** 



















#### **Austin Memorial Park Cemetery (1927)**





















## Next Steps

- Transition master plan team to implementation team to track cemetery master plan recommendations.
- Implement governance recommendations to provide additional guidance regarding municipal cemetery operations.
- Move forward with seeking historic designations for the cemeteries.
- Continue to explore opportunities for partnerships, with a focus on educational and historical programming.
- Determine funding strategies, ie capital bond or grant opportunities, to implement plan recommendations.
  - Remainder of 2012 Bond will be allocated to plan priorities.
  - Development of future cemetery bond package based on plan priorities.
