REGULAR MEETING Wednesday, August 19, 2015

1. Approve the minutes of the Public Utilities Committee meeting of June 17, 2015.

3. Staff briefing, invited testimony, and policy discussion to consider a resolution on stopping the addition of fluoridation to treated water. (Notes: This item will be taken up jointly with the Health and Human Services Committee.)

6. Briefing, public comment, and possible action related to Austin Resource Recovery organics Collection Pilot Program and possible city-wide implication.

The committee did not take any action on this item.

7. Staff briefing, discussion and possible action on the Fiscal Year 2016 drainage charge base rate assumption.

The committee did not take any action on this item but recommends keeping all exemptions the same.

ITEMS FOR COMMITTEE CONSIDERATION

 Consider and develop recommendation relating to an ordinance authorizing negotiation and execution of an amended water cost reimbursement agreement with CLUB DEAL 120 WHISPER VALLEY, L.P. and CLUB DEAL 116 INDIAN HILLS TX, L.P. for the design and construction of water mains in an amount not to exceed \$21,200,000. This ordinance would supersede ordinances 20100527-006, 20100826-004, 20130117-015, and 20140807-013.

There was a motion made by Council Member Garza and second by Council Member Zimmerman to take the item to the Audit and Finance Committee. Motion was approved on a 3-0 vote with Council Member Kitchen off the dais.
