

# Central Health Board of Managers – Considerations

Founded in 2004 by a vote of Travis County residents, Central Health is here to make our community stronger by investing in access to health care for our most vulnerable residents. We are the local public entity that connects low-income Travis County residents to high-quality, cost-effective health care.

By eliminating health disparities and improving safety-net health care delivery, we are transforming Travis County into a model healthy community.

## Governance

Central Health is a separate political subdivision of the State of Texas and is not a part of Travis County Government. The boundaries of our health care service area are contiguous with Travis County.

Central Health is governed by a nine-member volunteer Board of Managers. Four of the members are appointed by the Austin City Council and another four are appointed by the Travis County Commissioners Court. Both governmental bodies jointly appoint the ninth member. Board members serve four-year appointments and may be reappointed.

Our Board of Managers has a broad and varied background, including community and social service, medical care, private business, government, and law. Understanding special districts, strategic planning, and complex financial relationships is important. Central Health's future success requires the foresight that extensive experience as a chief executive officer, certified public accountant, or finance director proffers. Having previously served in a demanding leadership position guiding the policy direction of a large multi-faceted community focused organization may also provide relevant experience.

Serving on the Board of Managers for Central Health is rigorous and requires a significant investment of time. In addition to the regular meetings which on average require 15 hours a month, special community events, community engagement and preparation for meetings may occur on weekends and evenings. The Board of Managers must hold public hearings and approve the budget every September placing additional time demands on top of the regular meeting schedule.

# Planning

Central Health's efforts are guided by a Strategic Plan. The plan is reviewed and revised annually by the Central Health staff and Board of Managers in order to address the everchanging challenges of the regional health care environment.

## Meetings

Central Health's Board of Managers meets the first Wednesday of the month. A minimum of five board members must attend a board meeting to constitute a quorum of the Board of Managers. Meetings of the Board of Managers must comply with the Open Meetings Act and are open to the public. Attendance is kept. (*This meeting currently begins at 5:30 p.m. and may last 3-5 hours.*)

## Committees

In addition to the monthly board of managers meeting, the chair will appoint a manager to serve on a minimum of two committees. Any manager may attend a committee meeting, but only appointed managers are considered in establishing a quorum to take action in the committee.

## The Board of Managers Committees:

Strategic Planning: Meeting occurs the second Wednesday of each month. (*This meeting currently begins at 12:00 p.m. and may last two hours.*)

Budget and Finance: Meeting occurs the third Wednesday of each month. While there are 4 appointed members of the committee, any 5 board members makes a quorum of this committee and all board members are strongly encouraged to participate in this committee. (*This meeting currently begins at 5:30 p.m. and may last 3-4 hours.*)

Ad Hoc Central Health Downtown Campus/Innovation Zone: Meeting occurs the fourth Friday of the month. This ad hoc committee has been meeting regularly due to the redevelopment of the Central Health owned property that currently houses University Medical Center Brackenridge. (*This meeting begins at 11:30 a.m. and may last two hours.*)

There are four additional committees that convene at the discretion of the Board Chair, at the request of their Committee Chair, or at staff request. These committees include the Audit and Compliance Committee, The Ad Hoc Women's Health Committee, The Executive Committee, and the Medical Committee. (*The committee meeting durations vary depending on the work at hand.*)
