

### M/WBE Summary

Public notice was given for the solicitation documents for CLMC543 Parking Expansion: Far South Clinic and Montopolis Neighborhood Center through the City's Vendor Connection web portal which resulted in 476 contractors receiving notification. Seven contractors obtained bid documents and two bids were received and opened on July 9, 2015. One of the bids received was from a certified firm. RS ELLIS INC., DBA SOUTHWEST CORPORATION submitted the lowest responsive bid of two bids received:

The contractor's choice of work methodology provides for nine areas of subcontracting opportunities which are listed below. Project specific sub-goals stated in the solicitation were 2.13% African American; 3.98% Hispanic; 0.98% Native/Asian, and 2.09% WBE. Total participation estimated on base bid amount of \$535,679.72:
