<p>The Emerging and Acute Infectious Disease Branch of the Department of State Health Services (DSHS) is awarding funding to enhance the City's epidemiological capacity, which refers to infectious disease preparedness and response efforts. The funding will support personnel, fringe benefits, equipment, supplies, training, travel, and other indirect costs. This funding opportunity is separate from any other existing epidemiological capacity contracts in place with DSHS.</p> <p>This funding is intended to:</p> <ul style="list-style-type: none">• Provide an epidemiologist to conduct infectious diseases preparedness and outbreak response activities;• Improve and assure operational readiness for infectious disease; and• Assure collaboration, coordination, and partnership with the local health care system and laboratories to assist in the development of infectious disease preparedness and response capability. <p>This amendment will affect the following performance measures:</p> <ul style="list-style-type: none">• The number of cases investigated that result in an intervention strategy.• Number of Emergency Response Plans reviewed annually.• Ensure one epidemiologist per 100,000 people. <p>The General Fund will not be required to contribute additional funds beyond those currently budgeted to this grant or to the funding of this position. When the grant funds expire, the Health and Human Services Department's need for the position will be evaluated and the position may be eliminated.</p>
