## ORDINANCE NO. 3 AN ORDINANCE LEVYING MUNICIPAL PROPERTY (AD VALOREM) 4 TAXES FOR THE CITY OF AUSTIN, TEXAS, FOR FISCAL YEAR 2015-2016. 5 6 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN: 7 8 **PART 1.** The City Council levies, approves, and orders to be assessed and collected for 9 the Fiscal Year 2015-2016, and for each subsequent calendar year until otherwise 10 ordained, on all property in the limits of the City of Austin that is not exempt from taxation, a property (ad valorem) tax at the rate of \$\_\_\_\_\_ per \$100 of taxable value. 12 The tax rate consists of two components, each of which are separately approved by 13 Council: \$\_\_\_\_\_ per \$100 of taxable value, the rate that, if applied to the total taxable 14 value, will impose the total amount published under Section 26.04(e)(3)(C) of the Texas 15 Property Tax Code (Tax Code), less any amount of additional sales and use tax revenue 16 that will be used to pay debt service; and \$\_\_\_\_\_ per \$100 of taxable value, the rate that, 17 if applied to the total taxable value, will impose the amount of taxes needed to fund 18 maintenance and operation expenditures of the City for the coming year. 19 PART 2.
