## **Department Overview**

• **Mission Statement:** The mission of the Communications and Technology Management (CTM) Department is to provide an excellent customer experience and deliver innovative business technology solutions so that our customers can meet their diverse business needs.

#### **Major Accomplishments**

- The first phase of the AMANDA case management system upgrade is well underway. Phase I of the project migrates to a browser version and improves accessibility and performance for users.
- The first phase of the Greater Austin Travis County Regional Radio System (GATRRS) Upgrade is complete. This phase replaces the microwave network at 12 radio tower locations.
- Three City departments are currently utilizing mobile devices to access city resources in the field. Mobile Device Management software secures, monitors, manages and supports mobile devices.





Description	Amount
