MBE/WBE:	This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 6.13% MBE and 1.28% WBE subcontractor participation.

This project will install approximately 9,600 linear feet of 30-inch diameter wastewater line from west of State Hwy 130 along the north and south banks of Harris Branch Creek to the Harris Branch Wastewater Package Plant. In addition, to remove an existing siphon line, this project will install approximately 2,056 linear feet of a new 12-inch gravity wastewater line connecting to the new 30-inch diameter wastewater line. Once completed, the new wastewater lines will allow the decommissioning of the Harris Branch Wastewater Package Plant, located along Arlington Mill Road. The existing Harris Branch Wastewater Package Plant was built in 1988 as a temporary facility by the Northwest Travis County MUD which later annexed by the Austin Water. Due to its advancing age and condition, it was decided to decommission the Harris Branch Wastewater Package Plant and send flows to the Wild Horse Wastewater Treatment Plant along Blue Bluff Road in Manor, Texas. The decommissioning will eliminate the annual costs associated with its maintenance, monitoring, and repair.

This project and the new interceptor contains, 7 tunnels including 2 tunnels crossing under Harris Branch creek. Because of the large percentage of tunneling on the project and due to the potential for encountering unknown conditions, a 10% contingency in funding has been included to allow for the expeditious processing of any change orders.

The contract allows 365 calendar days for completion of this project. This project is located within zip code 78653 (District 1) and is managed by the Public Works Department.

SJ Louis Construction of Texas, Ltd. is located in San Antonio, Texas.

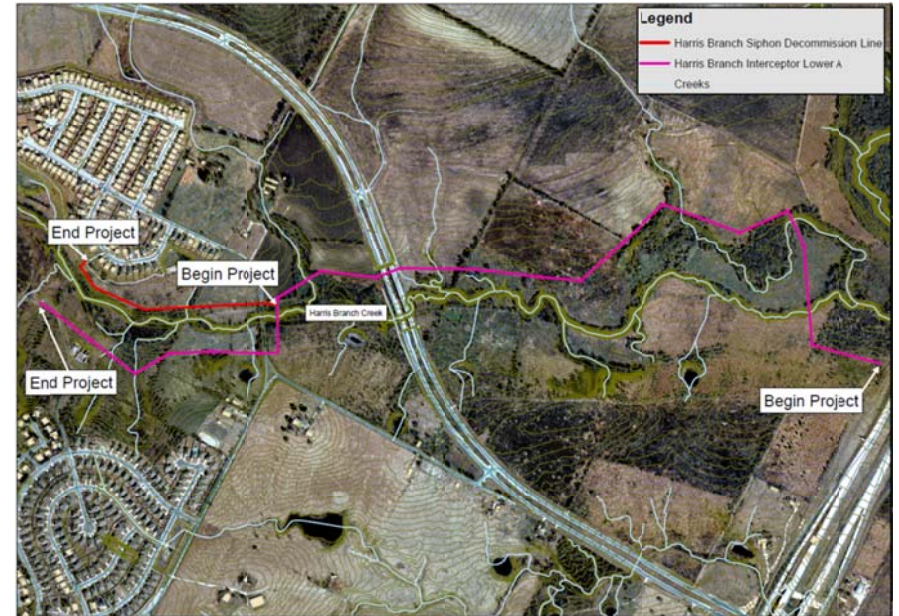
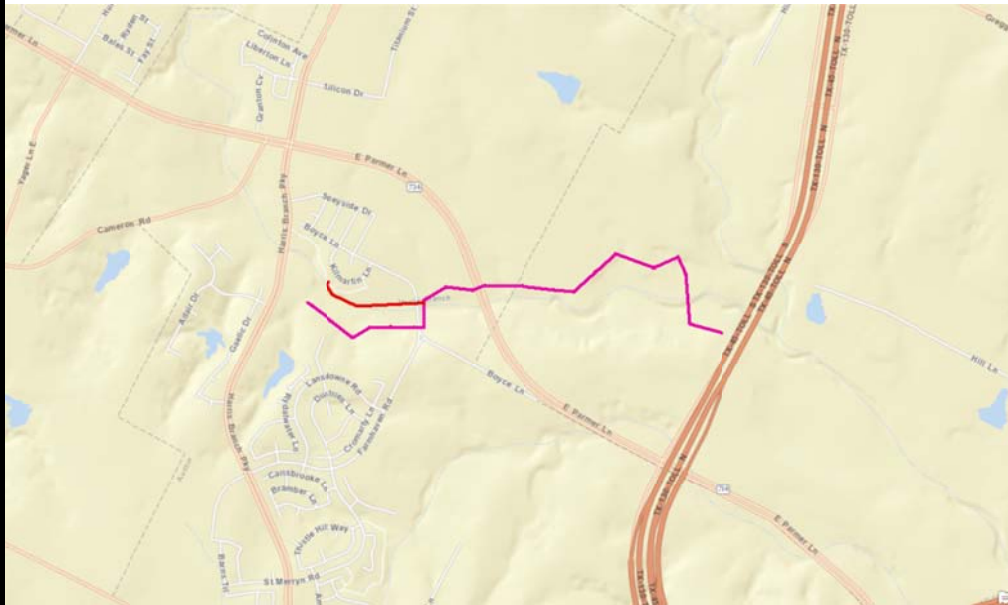
