

M/WBE Summary

Participation subgoals stated in the original approved compliance plan for the Agreement were 1.9% African American; 9.0% Hispanic; 4.9% Native/Asian American and 15.8% WBE. The recommended firm provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Additional authorization has been listed under the Prime firm, as subconsultant utilization for the additional authorization which has not been finalized. Prior to issuance of a notice to proceed, the Prime firm will submit their subconsultant utilization plan which will demonstrate how they will use their approved subconsultants in accordance with the established procedures and the MBE/WBE Procurement Ordinance and Rules.
