These contracts will provide the City's six golf facilities with sureplay and topdress sand as specified by the United States Golf Association (USGA). In addition to providing the appropriate material for golf course bunkers (sand traps), the sand is also used to level and shape greens and promote the drainage required to conserve water.

The two types of silica sand purchased on this contract are different colors; both are required to maintain the courses original construction. The silica sand provided by Osburn Materials, Inc. will be used for greens maintenance at Jimmy Clay/Roy Kiser, Hancock and Greyrock courses, while the material from Texas Sports Sands, Inc. will support green and bunker maintenance at Morris Williams and bunker maintenance at Greyrock.

The prior contract for the majority of this material has expired, forcing the Parks and Recreation Department to procure the material on higher priced spot-buys to maintain the golf courses.

## PRICE ANALYSIS

- Sole bids received. While there are several pits that provide reasonably priced silica sand in the state of Texas, a. the true cost is transportation. For that reason, only pits in Central Texas can provide this type of material to the City competitively.
- 100 notices were sent including three MBEs and no WBEs. Two bids were bids were received with no b. response from the MBEs/WBEs.
- The pricing offered represents a 4.2% decrease from the last White Sureplay Silica Sand purchase made in c. 2012 and a 13% increase from the last Silica Sand purchase made in 2008. This increase in cost is consistent with the price index which shows an 18% increase in cost for this commodity.
