PROPOSAL

Relocate a ca. 1939 house to outside the city.

ARCHITECTURE

One-story, wing-and-gable plan frame house with a partial width, integral shed-roofed independent porch on plain, square, wood posts; single and paired 1:1 fenestration; scalloped wood ornamentation at the base on the tympanum of the principal front-facing gable; boxed wood chimney.

RESEARCH

The house was built in 1939 by Virgil and Malissie Pope, who lived here until around 1943. Virgil Pope was a Texas-born painter, who had previously worked as a night watchman at the Texas School for the Deaf. Around 1943, the house was purchased by Earl and Ermer Grace Summerow. Earl Summerow was born near Houston, and worked at a tire store and as a city firefighter before joining the U.S. Navy during World War II. His ship exploded while being loaded with ammunition in Papua New Guinea in 1944, killing all aboard. His widow is listed as the owner and occupant of the house in the 1947 city directory; she then married electrician Alfred Hess and lived here with him in the late 1940s. From around 1950 on, the house has been a rental unit, with tenants including an employee of the State Department of Agriculture, a waitress at the old Night Hawk, and in the early 1990s, famed local guitarman Charlie Sexton.

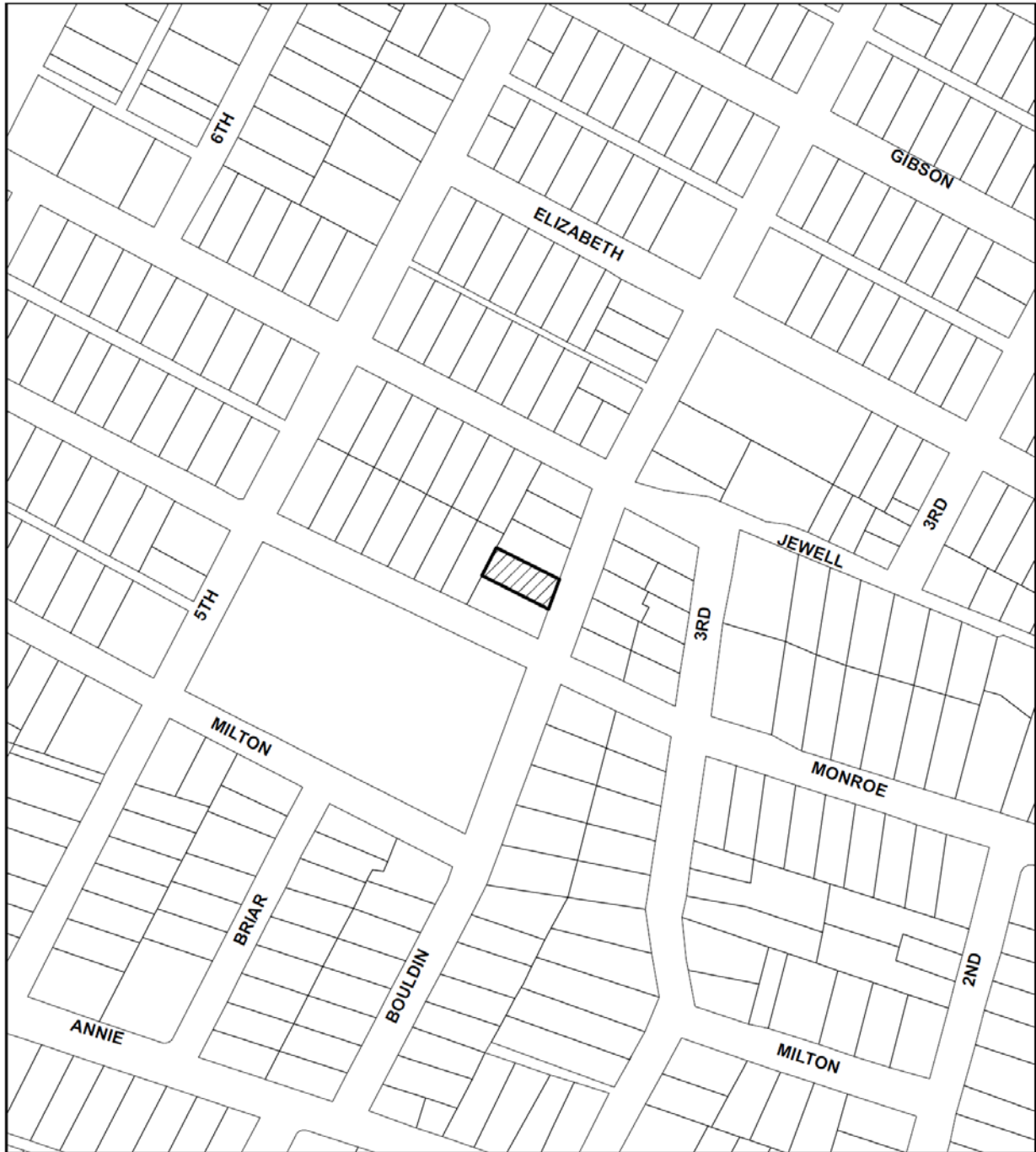
STAFF COMMENTS




The house is not listed in any City survey.

STAFF RECOMMENDATION

The house is proposed for relocation rather than demolition, which staff supports, although staff contends that the better alternative would be to adaptively re-use this house, which represents the scale, materials, and massing of the neighborhood. However, this house does not have the architectural nor the historical significance to warrant individual designation as a historic landmark, so staff must recommend release of the permit, upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES

Virgil and Malissie Pope (ca. 1939 – ca. 1943)

Virgil and Malissie Jane Pope appear in the 1940 U.S. Census as the owners of this house, which was worth \$2,000. Virgil Pope was 50, had been born in Texas, and was a painter. Malissie Jane Pope was 51, had been born in Missouri, and had no occupation listed. With them lived their daughter, Gladys A., 26, who had been born in Texas and had no occupation listed; and another daughter, Lake Scott, 26, who had been born in Oklahoma and had no occupation listed. Lake's husband, Adrian T. Scott, 22, had been born in Texas and was a delivery man for cleaning and pressing company.

The 1930 U.S. Census shows V. and Mellissia Pope as the renters of the house at 1008 S. 1st Street in Austin. V. Pope was a 41-year old Texas-born night watchman at the Deaf School. Mellissia Pope was 42, had been born in Missouri, and was a cleaner and presser at a cleaning shop. They had 3 children: Gladys, 16; Truman [?], 14; and Lake, 12. All three girls had been born in Texas.

VIRGIL POPE

Funeral services for Virgil Pope, 72, of 505 Normandy will be held Thursday at 1 p.m. at the Wilke-Clay Funeral Home with Rev. Gordon B. Bays officiating.

He had been a resident of Austin for 36 years and was a member of Congress Avenue Baptist Church. He was a retired painting contractor and was associated with the sheriff's department for a number of years.

He is survived by his widow, Mrs. Virgil Pope; three daughters, Mrs. Robert Wheeler, Mrs. John Haldeman and Mrs. John R. Durbin, all of Austin; two sisters, Mrs. Maude Spurlock of Fort Worth, and Mrs. Aubry Jones of Cleburne; a brother, Arthur Pope of Cleburne; five grandchildren and three great-grandchildren.

Pallbearers will be R. E. Harsch, A. B. Burt, Lee Whitaker, Clyde Hill, M. L. Leath and William A. Hergotz.

Burial will be in Capital Memorial Gardens.

Earl J. Lee and Ermer G. Summerow (ca. 1943 – ca. 1944)**Erma Grace Summerow Hess and Albert B. Hess (ca. 1945 – ca. 1950)**

Earl J. Lee Summerow, Jr. and his wife, Ermer G. Summerow are listed in the 1940 U.S. Census as the renters of an apartment at 1117 W. 5th Street in Austin. Earl J. Lee Summerow was 21, had been born in Texas, and was a service man for a retail tire and rubber company. Ermer G. Summerow was 20, had been born in Texas, and was a stenographer for a retail tire and rubber company. They had no children listed with them. Earl Summerow had lived in rural Travis County in 1935.

Earl J. Lee Summerow was born in 1918 in Goose Creek, Harris County, Texas. He died on the U.S. S. Mount Hood in Seadler Harbor, Manus Island, Admiralty Islands, Papua New

Guinea on October 10, 1944 when the ship exploded while being loaded with ammunition. All 350 men on board were killed.

Ermer Grace Summerow married Alfred Berge Hess after Earl J. Lee Summerow's death. They lived in this house in the late 1940s. E. Grace Summerow Hess died in Kerrville in 2008; Alfred Hess died in Kerrville, Texas in 2009.
