
Colony Park Sustainable Community Initiative
 Master Plan and Design identified a need for basic
 health care services in Colony Park

- Community stakeholders approached PARD in last quarter of 2014 to assist in facilitating negotiation between HHSD and a health provider for temporary health services
- PARD worked with AISD, HHSD, AFD, EMS, and Community members to explore all possible options




Age Adjusted All Cause Mortality Rate By Year 2000 Census Tract Travis County, 2004 and 2008





Age Adjusted Cancer Mortality Rate by Year 2000 Census Tract Travis County 2004 - 2008











In January of 2015, Parks Board made a recommendation to the Director to approve of temporary use of space at Colony District Park/Turner Roberts Recreation Center for the purposes of providing temporary community health clinic services and waive associated mitigation fees.



- Parks Board Temporary Use
 - January 27, 2015
- Agreement Development
 - HHSD with Community Care
- Community Care Operations Begin
 - March 2015
 - Out of 99 available appointments to date , 89 patients scheduled



PARD returns to Parks Board **as a 1st step** to seek support for use of clinic space at Turner Roberts for longer than what would be considered temporary

- "Chapter 26" Process- 1 Year or less provisions
 - Parks and Recreation Board (completed January, 2015)
- "Chapter 26" Process- 1 Year or greater provisions
 - Public Hearings
 - Council Approval





- Health Clinic Services provided by Community
 Care at Turner Roberts Recreation Center
- Contract monitored by HHSD
- Space usage supported by AISD
- Facility Use
 - 1 weekday a month from 8 am to 4 pm
 - Use of 2 rooms in the facility
- Minimal impact to existing center programs
- Waiver of mitigation fee
 - Potential Rental Loss Consideration- \$10,560
 annually (rooms have no rental history)

Recommendation:

Make a recommendation to the City Council for approval of continued use of 2 rooms (1,870 sq. ft.) at Colony District Park/Turner Roberts Recreation Center for the purposes of providing community health clinic service.
