Participation subgoals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native Asian; 15.80% WBE. The recommended firms provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications was issued on June 9, 2015 through the City's Vendor Connection web portal, which resulted in 3809 firms receiving notice. The solicitation was obtained by 114 firms and seven submitted qualification statements. None of the firms were certified MBE /WBE firms.

Once the assignment is made, and prior to issuance of a notice to proceed, the Prime consultant will submit their subconsultant utilization plan that will demonstrate how they will use their approved subconsultants in accordance with the established procedures and the MBE/WBE Procurement Ordinance and Rules.
