# HISTORIC LANDMARK COMMISSION NOVEMBER 16, 2015 DEMOLITION AND RELOCATION PERMITS HDP-2015-1008 1209½ WILLOW STREET

## **PROPOSAL**

Demolish a ca. 1910 house.

#### ARCHITECTURE

One-story, rectangular-plan, hipped-roof, frame house with a partial-width, hipped-roof independent porch to the left of the principal façade; recessed front entry with sidelights and a transom; single 1:1 windows with some replacement windows.

## RESEARCH

The house appears to have been built around 1910. The first known occupant of the house was Sarah Rios, who lived here briefly. She was a widow with two adult sons – one worked for a lumberyard, the other as a cotton sampler. By 1911, the house was owned and occupied by Otto Grein and his wife, Bonnie. Otto Grein was a native Austinite, and grew up on East Avenue. His widowed mother was a candy maker, and Otto and another brother both worked as baggage handlers for the International and Great Northern Railroad. Otto continued to work for the railroad for the rest of his working life – he became the ticket agent in the depot, and continued in this capacity even when the International and Great Northern Railroad became the Missouri Pacific Railroad in the mid-1920s. Otto's wife Bonnie died in 1936; he continued to live in this house with his children until around 1940. He rented out the house to Charles Bales and his wife, Lila, through the 1940s. Charles Bales was also employed by the Missouri Pacific Railroad as a messenger.

In the late 1940s, the house was rented by Cecil and Gertrude Dillingham. Cecil Dillingham had no occupation listed in the city directories, but Gertrude Dillingham was the assistant treasurer for the Texas Conference of Parents and Teachers. The house has remained a rental property until recently – tenants have included Air Force families and construction workers.

## STAFF COMMENTS

The house is not listed in any City survey.

## STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use to the greatest extent possible; this house is over 100 years old, and represents the architectural and historical character of the neighborhood. If rehabilitation and adaptive re-use is not feasible, then staff recommends release of the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

## **BIOGRAPHICAL NOTES**

## Otto and Bonnie Grein (ca. 1911 – ca. 1940)

The 1910 U.S. Census shows Otto Grein as the 21-year old son of Augusta Grein, a 50-year old German-born widow who lived at 207 East Avenue in Austin. Otto Grein was a baggage man for the railroad; his mother, Augusta, was a candy maker for a confectionery. Otto's next younger brother, Charles, 19, was also a baggage man for the railroad.

His 1917 World War I draft registration card shows that Otto Grein was 28, having been born December 2, 1888 in Austin. He was living at 1209 Willow Street. He was a depot ticket agent for the International and Great Northern Railroad. His family consisted of his wife and sister-in-law. He was of medium height and a stout build. He had grey eyes, light hair, and was balding.

The 1920 U.S. Census shows Otto and Bonnie M. Grein as the owners of this house. Otto Grein was 31, had been born in Texas to German-born parents, and was a ticket agent for the International and Great Northern Railroad. Bonnie M. Grein was 30, had been born in Texas, and had no occupation listed. They had a son, Robbie L, 11 months. In addition, in the house lived Bonnie's sister, Margaret Green, 21, who had been born in Texas and was a clerk in dry goods store.

The 1930 U.S. Census shows Otto and Bonnie Grein as the owners of this house, which was worth \$4,000. Otto Grein was 39, had been born in Texas to German-born parents, and was a ticket agent for the Missouri Pacific Railroad. Bonnie Grein was 39, had been born in Texas, and had no occupation listed. They had a son, Robert L, 11, who had been born in Texas and had no occupation listed; and a daughter, Mary E., 9, who had been born in Texas and had no occupation listed.

The 1940 U.S. Census shows Otto Grein as a 50-year old widower, who lived with his son, Robert L, 21, on Route 2 in Travis County; they owned their house, which was worth \$300. Otto Grein was a Texas-born ticket clerk for the railroad. Robert L. Grein was a farm laborer.

According to his 1963 death certificate, Otto Grein was living at 4401 E. Riverside Drive at the time of his death at the age of 73. He had been born in Austin, and worked as a ticket agent for the Missouri Pacific Railroad.

The 1940 U.S. Census shows Charles and Lila L. Bales as the renters of this house. Charles Bales, Jr. was 23, had been born in Texas, and worked as a baggage porter for the railroad. He had lived in Uvalde, Texas in 1935. Lila L. Bales was 20, had been born in Alabama, and had no occupation listed. She had lived in Weslaco, Texas in 1935. They had a newborn son, C. Larry Bales.

Also at this address are Charles and Nina Faye Rush, who are listed as renters. Charles Rush was 23, had been born in Mississippi, and was a company clerk for the Air Corps. He had lived in Clarksdale, Mississippi in 1935. Nina Faye Rush was 22, had been born in Texas, and was a cashier for E.M. Scarbrough & Sons, a department store.

At the rear of the house lived Freda and Roland Manske, also listed as renters. Freda Manske was a 48-year old Kentucky-born widow, who was a practical nurse for a private family. Her son, Roland, was 22, had been born in Texas, and was a purchasing man for a grocery store. They had lived in Paris, Texas in 1935. The 1930 U.S. Census shows Henry and Freda M. Manske as the owner of a house worth \$3,300 in Paris, Texas. Henry Manske was 46, had been born in Texas to German-born parents. Freda M. Manske was 37, had been born in Kentucky to German-born parents. They had 2 sons: Elton, 14; and Roland, 11.

## Cecil and Gertrude Dillingham (ca. 1948 – ca. 1950)

Cecil and Gertrude Dillingham appear in the 1940 U.S. Census as lodgers in the home of Conrad and Grace Pfluger, who lived at 3107 San Gabriel Street in Austin. Cecil Dillingham was 35, had been born in Texas, and was a carpenter foreman; Gertrude Dillingham was 30, had been born in Texas, and had no occupation listed. They had no children listed with them. According to her 1974 death certificate, Juanita Gertrude Dillingham died of asphyxiation and

aspiration of gastric contents, with alcoholic gastritis, cirrhosis of the liver, and acute pancreatitis listed as other significant conditions contributing to her death. She was born in Austin in 1915 and is listed as a housewife.

DILLINGHAM Juanita Mrs. Gertrude Dillingham, 58, 1202 Marcy Dr., died at her home Sunday, She was a member of the Order of Eastern Star, the Royal Neighbors and the First Baptist Church and had been a lifelong resident of Austin. Survivors include her husband, Cecil Dillingham of Austin; one brother, Forrest Gilbert of Gardengrove, Calif.; one sister-in-law, Mrs. Margie Gilbert of Austin; and a number of nieces and nephews. Funeral will be 3:30 p.m. Hyltin-Manor Monday at Funeral Home with Dr. William Ε. Denham Jr. officiating. Burial will be in Capital Memorial Gardens.
