### **Common Acronyms**

- **SER** = Service Extension Request
- **CCN** = Certificate of Convenience & Necessity TCEQ-authorized service area
- **ERI** = Environmental Resource Inventory
- **LUE** = Living Unit Equivalent

Typical flow produced by a single-family residence located in a typical subdivision (3.5 persons)

**OSSF** = On-Site Sewage Facility

# What is a Service Extension Request?

- A Service Extension Request (SER) is an application for City water or wastewater service from a property owner or developer. Required when:
  - The nearest point on the property boundary is located >100 feet from an accessible water or wastewater system, or
  - Existing infrastructure is not adequate for proposed project demands.
- Service may involve construction of a new line or an associated facility or upgrades to existing lines or facilities.
- Applicant pays for associated infrastructure, as outlined in the SER.




# **Expiration of SERs**


- All new SERs expire on the latest of:
  - 180 days after the date of approval;
  - the date a pending development application expires; or
  - the date an approved development application expires.
- For projects with a recorded plat, the SER never expires for the platted portion of the property.
- If a project's intensity, proposed land uses, lot configuration, or anticipated service demands change, an amendment to the previously-approved SER may be required at the discretion of the Austin Water Director.

# **City Council Review**

- Per LDC 25-9-35, SERs require Council approval for properties located:
  - ☑ In the Drinking Water Protection Zone (DWPZ) and
  - ☑ Outside the City's Full Purpose Jurisdiction.

# **SER Council Review Process**

- 1. Austin Water Utility SER Application Review
- 2. Watershed Protection Department (WPD) Staff Review & Recommendation
- WPD Staff Briefing to the Environmental Commission & Environmental Commission Recommendation
  Note: Approval of service extensions cannot be conditioned, as mandated by State Law.
- 4. Water & Wastewater Commission Recommendation
- 5. City Council Public Utilities Committee Recommendation, as needed
- 6. City Council Action

## **WPD Internal Review**

#### Internal guidelines for review include:

- Site Considerations
- Code Compliance
- Development Impacts
- Environmental Impacts
- Long-Term Planning Considerations
- Nearby Council-Approved SERs

Staff formulates a recommendation and briefs the Environmental Commission on the application, location, and internal review findings.
