The Rio Grande 24th Street to 29th Street Reconstruction and Utility Adjustments project will reconstruct Rio Grande Street from 24th to 29th street.

The work will include 3,170 linear feet of 12-inch diameter water line, 131 linear feet of 8-inch diameter wastewater line, full depth street reconstruction, bike lane additions, storm drainage improvements, and streetscape improvements including plantings and benches, and fire hydrants. The project is tentatively scheduled to begin in January 2016 and be substantially complete in July 2017.

Public communication to the affected areas has been continuous and is achieved through a combination of emails, mailings and a project website.

This project is not time sensitive.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right of way, a 5% contingency in funding has been included to allow for the expeditious processing of any change orders.

The contract allows 400 calendar days for substantial completion of this project. This project is located within zip code 78705 (District 9).
