

M/WBE Summary Construction Contract with Allowance and Contingency

Public notice was given for this solicitation, CLMC557 Howard Lane # 1 Reservoir Improvements, through the City's Vendor Connection web portal which resulted in 275 contractors receiving notification. 11 contractors obtained the bid documents and four bids were received and opened on September 24, 2015. None of the bids received were from MBE/WBE certified firms. Blastco Texas, Inc. submitted the lowest responsive bid of four bids received including a \$50,000 allowance:
