Additional Backup Information

This project decommissions a lift station constructed in 1983 and located along Lindshire Drive south of Slaughter Lane. Since its construction, new wastewater infrastructure has been installed south of the lift station in conjunction with this area's development. As part of the lift station decommissioning, the wastewater flow that the lift station currently handles will be re-routed to this new wastewater infrastructure. The project will install 475 linear feet of 8-inch diameter wastewater line. The elimination of the lift station will improve overall system reliability and eliminate the expense of maintaining this lift station.

This project removes an outdated and failing pump station and a delay in the project may result in the continued expense of maintenance and repair.

The project team has met with the neighborhood association and made a presentation at a meeting. The team is in contact with the neighborhood association's newsletter group and has been keeping them apprised of the status of this project.

Due to the potential for unknown conditions, a 5% contingency in funding has been included to allow for the

expeditious processing of any change orders. A contingency is an additional amount of money added to the construction budget to cover any unforeseen construction costs associated with the project.

The contract allows 90 calendar days for completion of this project. This project is located within zip code 78748 (District 5). The project will be managed by the Public Works Department.
