

M/WBE Summary

Participation subgoals stated in the solicitation were 1.9% African American; 9.00% Hispanic; 4.90% Native/Asian; 15.80% WBE. The recommended firm provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department. The alternate firm provided a MBE/WBE Compliance Plan that met the goals and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications was issued on June 9, 2015 through the City's Vendor Connection web portal, which resulted in 3076 firms receiving notice. The solicitation was obtained by 168 firms and eight submitted qualification statements. None of the firms were certified MBE/WBE firms. Of the eight firms evaluated, two firms were short-listed and interviewed. Interviewing of the short-listed firms resulted in the following recommendation.
