Amendment: C20-2015-010 Porch Encroachment

Description: Consider an amendment to Title 25 of the City Code related to street side yard porch encroachment.

Proposed Language: See attached draft ordinance.

Summary of proposed code changes:

• Will allow street side yard porches to project up to five feet into the setback.

Background: Initiated by Planning Commission on September 22, 2015

Current code allows front porches in zoning districts MF-3 or more restrictive to project up to five feet in a front yard setback; this provision is applicable city-wide. The proposed code amendment will allow for a similar provision for street side yards, such that a porch on a street side yard (ie a corner lot) could project up to five feet into the setback.

Staff Recommendation: Approve proposed ordinance.
