The Interlocal Agreement provides for design and construction of water line appurtenances located within the Travis County Right Of Way. Per the Interlocal Agreement with Travis County, the City of Austin will utilize County's design engineer, Hanrahan Pritchard Engineering, to design relocations and adjustments to the water line appurtenances that are in conflict with the proposed roadway improvements, and county will include construction of the utility adjustments into the roadway work.

The roadway in this interlocal agreement was identified as a transportation improvement project by the County. Austin Water's existing water line appurtenances are required to be adjusted to accommodate the proposed roadway improvements, and this agreement will allow those water infrastructures in conflict to be adjusted. Executing this interlocal agreement will bring together the efforts of the County and Austin Water in the design and construction of the roadway improvements and utility adjustments to minimize impacts to the public and save costs.

The cost for the design is \$8,600. The estimated construction cost is \$39,750 plus a 10% contingency amount of \$3,975. The total contract amount is \$52,325.

This project requires adjustments to 6 air release valve manholes, 6 fire hydrants, 19 water valve casting adjustments, 7 combination air and vacuum release valves, and 2 drain valves. The City will pay all costs of engineering design, and testing of the improvements and, will reimburse Travis County construction costs of the improvements, including the cost of change orders made necessary by field changes to address unanticipated conditions under the terms and conditions in this agreement. Travis County shall obtain the written approval from the City for all change order requests prior to Travis County issuing the approved change order to the contractor.

A 10% contingency in construction funding has been included to allow for the expeditious processing of any change orders. All dates are dependent upon County design and construction contract.

This project is located within zip codes 78747, within the extraterritorial jurisdiction (ETJ) and council district 2. This project is managed by Austin Water.
