PROPOSAL

Demolish a ca. 1923 house.

ARCHITECTURE

One-story, rectangular-plan, hipped-roof, frame house with synthetic siding; front-gabled entry hood over principal entry on triangular knee braces; single and paired 1:1 fenestration.

RESEARCH

The house appears to have been built around 1923. The first owners and occupants were Reginald C. and Norene McCoy, who lived here until around 1928. Reginald McCoy was a car mechanic, who later went to work as a mechanic for the Austin Laundry and Dry Cleaning Company. City directories of the mid-1920s also show Clement C. and Addie McCullough as owners of this house. Clement C. McCullough was a carpenter. He and Addie lived here until around 1943.

Annie Jennings, a widow, lived here from the mid-1940s until her death in 1955. Her son, W. Morgan Harkleroad, and his wife, Estella, are listed as the renters of the house in the 1955 city directory. Harkleroad was an engineer for the Southern Pacific Railroad.

The house was a rental through the mid-1960s. Isabel and Mary Perez are listed as the owners of the house in the 1968 city directory. He was a warehouseman for Nelson Davis & Son, a wholesale grocery business. The house was then a rental property again through the 1970s and 1980s.

STAFF COMMENTS

The house does not appear in any City survey. The house has vinyl siding, and it appears that the front of the house has been modified, in that it most likely had a front porch that has been infilled.

STAFF RECOMMENDATION

Release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.

BIOGRAPHICAL NOTES

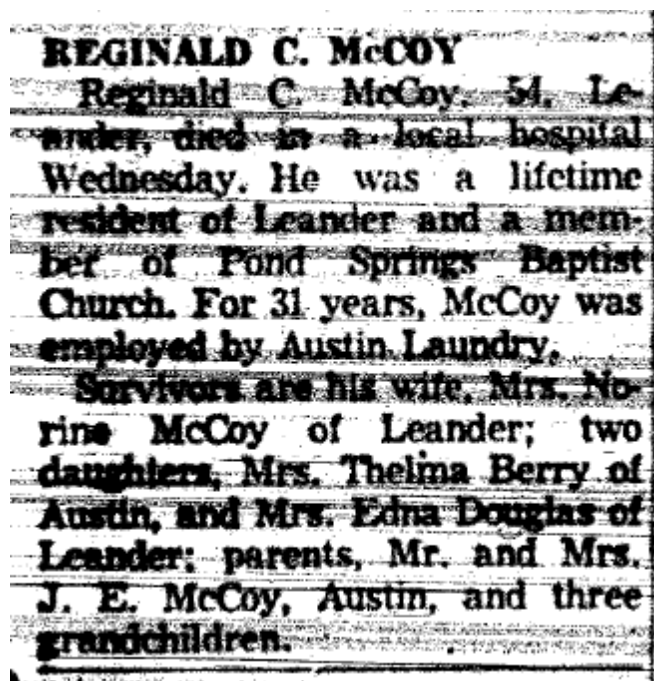
Reginald and Norine McCoy (ca. 1922 – ca. 1928)

Reginald McCoy appears in the 1920 U.S. Census as the 17-year old son of J.E. and Fanny E. McCoy who owned their farm in rural Travis County. He was a wagon driver. His father was a stone mason on a road project.

The 1930 U.S. Census shows Reginald and Norine McCoy as the owners of the house at 2509 E. 2nd Street in Austin, which was worth \$2,100. Reginald McCoy was 28, had been born in Texas, and was a salesman for a laundry. Norine McCoy was 26, had been born in Texas, and had no occupation listed. They had 2 daughters: Edna, 2; and Thelma, 1.

The 1940 U.S. Census shows Reginald and Edna Norine McCoy as the owners of the house at 1108 Springdale Road, which was worth \$2,450. Reginald McCoy was 38, had been born in Texas, and was a truck driver for a laundry. Edna Norine McCoy was 36, had been born in Texas, and had no occupation listed. They had 2 daughters: Edna, 12; and Thelma, 11.

According to his 1957 death certificate, Reginald Cloud McCoy was born October 19, 1902 in Travis County; he was employed by the Austin Laundry and Dry Cleaning Company at the time of his death, and was living in Leander, Texas.

Clement C. and Addie McCullough (ca. 1926 – ca. 1943)

Clement C. and Theodosia McCullough are listed in the 1910 U.S. Census for rural Travis County. Both were 35. Clement C. McCullough had been born in Tennessee; Theodosia A. McCullough had been born in Maryland. They rented their farm. They had 2 daughters: Suesta, 14; and Grave, 12, both of whom had been born in Texas. The 1920 U.S. Census shows Clem C. and Addie McCullough as the owners of a farm in rural Travis County. Both were 45 years old. They had a daughter, Allene, 15.

The 1930 U.S. Census shows Clem and Addie McCullough as the owners of this house, which was worth \$3,500. Both Clem and Addie were 55. Clem was listed as a building contractor; Addie had no occupation listed. They had a daughter, Martin Reddick, 29, who had been born in Texas, was divorced, and worked as an assistant in a doctor's office. Martin had a daughter, Dorothy, 9.

The 1940 U.S. Census shows C.C. and Addie McCullough as the owners of this house, which was worth \$2,400. C.C. McCullough was a contractor and carpenter; Addie McCullough had no occupation listed.

C. C. McCULLOUGH

C. C. McCullough, 88, died at his home, 2017 East Second street, Friday. Besides his widow he is survived by his stepmother, Mrs. R. T. McCullough of Taylor; five daughters, Mrs. A. L. Davis, Mrs. V. B. Akord, Mrs. Ethel Anderson, Mrs. Meta Reddick and Mrs. Johnnie Elkins, all of Austin; four sisters, Mrs. Lizzie Bailey and Mrs. Julia Parsons of Manor, Mrs. Ada Bothmer of Austin and Mrs. Blanche Simmons of Taylor; and two brothers, R. C. McCullough of Austin and A. E. McCullough of Taylor.

Funeral services will be held from the East avenue Baptist church Sunday at 4 p. m. with the Rev. E. L. Sparks officiating. Burial will be in Oakwood cemetery. Pallbearers will be R. H. Wingard, J. E. Adair, A. D. Beard, G. W. Griffin, F. J. Smalley and H. H. Townsley. The body is at his home.
