For the goods and services required for this contract, there were insufficient subcontracting opportunities; therefore, no subcontracting goals were established.					
Additional Backup Information						

The contract will provide a constant supply of TOMAR light bars, sirens, and replacement parts and accessories for the emergency vehicles used by the Austin Police Department, Austin Fire Department, and Emergency Medical Services Department.

The TOMAR Scorpion light bar and siren system is the primary light and signaling system used for the City's marked patrol cars. The officers are trained to use the controls for the device under all operating conditions. The City's public safety departments use a unique light pattern configuration on their TOMAR light bars. Using another brand of light bar would require another control application build out to duplicate this unique pattern. During a crisis or forward deployment the interoperability of parts allows the transfer of parts from one vehicle to another, making one good patrol car out of two broken cars during a forward deployed event. The light bar and siren industry has no standardization of controls for their devices. Each manufacturer uses its own unique combination of buttons and switches to operate their equipment. Using another manufacturer would require the replacement of all the existing light bars and sirens as well as retraining of all of the officers for the operation of the new equipment.

The current contract does not expire until March 2018, however the remaining spending authority is inadequate and will soon be depleted. This new contract adequately addresses the equipment needed to properly outfit these vehicles due to the growth of the City.

TOMAR Electronic, Inc. is the manufacturer of these products and has provided deep discounts up to 40% off list prices and represents the best value to the City.
