## CONSENT AGENDA

- AHFC1. Approve the minutes of the November 19, 2015 Board meeting of the Austin Housing Finance Corporation.  
**The motion to approve the minutes of the November 19, 2015 Board meeting of the Austin Housing Finance Corporation was approved on Vice President Tovo's motion, Director Garza's second on an 8-2 vote. Those voting aye were: President Adler, Vice President Tovo, Directors Gallo, Garza, Houston, Kitchen, Pool and Renteria. Those voting nay were: Directors Troxclair and Zimmerman. - AHFC2. Approve a resolution amending the Fiscal Year 2015-2016 Austin Housing Corporation Grant Operating Budget in the amount of \$1,391,143.52 and the Housing Assistance Fund Budget in the amount of \$800,000 for a total appropriation increase of \$2,191,143.52.  
**Resolution No. 20151217-AHFC002 was approved on approved on Vice President Tovo's motion, Director Garza's second on an 8-2 vote. - AHFC3. Authorize negotiation and execution of Amendment No. 2 to the Fiscal Year 2015-2016 Service Agreement with the City of Austin by increasing funding for the HOME grant fund program in the amount of \$1,391,143.52, for a total contract amount not to exceed \$19,868,116.52.  
**The motion authorizing the negotiation and execution of amendment number two to the Fiscal Year 2015-2016 Service Agreement was approved on Vice President Tovo's motion, Director Garza's second on an 8-2 vote. - AHFC4. Authorize an increase of \$700,000 to an existing loan agreement with Foundation Communities, Inc., or an affiliated entity, for a total loan amount not to exceed \$1,700,000 for the development of Bluebonnet Studios, a Single Room Occupancy residential facility at 2301 South Lamar Boulevard for very low-income individuals and individuals exiting homelessness.
