Funding in the amount of \$172,784 is available from the U.S. Department of Health and Human Services, Health Resources and Services Administration. The grant period is from March 1, 2015 through February 29, 2016. No City match is required.

Additional Backup Information

The City's Health and Human Services Department (HHSD) received a grant award in the amount of \$4,662,537 from the U.S. Department of Health and Human Services for the Ryan White Part A HIV Emergency Relief Project (Part A) and Minority AIDS Initiative (MAI). On December 11, 2015, HHSD received an additional \$83,537 in grant funds, resulting in a carryover of Part A and MAI grants from Fiscal Year 2014-2015, resulting in a total of \$4,662,537 for the current appropriation in the Fiscal Year 2015-2016 budget.

The Austin Transitional Grant Area plans to use the grant funds for direct HIV core and support services.

Services for the additional funds will be delivered by our Part A-MAI providers: AIDS Services of Austin, Inc., Austin/Travis County Mental Health Mental Retardation C.A.R.E. Program, Community Action of Central Texas, Inc., David Powell Community Health Center, Project Transitions, Inc., Waterloo Counseling Center, Wright House Wellness Center, as well as the Communicable Disease Unit via an intradepartmental agreement with the Disease Prevention and Health Promotion Division.

This council item is time sensitive to ensure that the services are provided to the community. The contract end date is February 29, 2016. A delay in amending these contracts may negatively impact meeting the grant's performance measures and the funder may terminate or suspend funding.

The General Fund will not be required to contribute additional funds beyond those currently budgeted to this grant. When the grant funds expire, the Health and Human Services Department's need for continuing funding will be evaluated and may be denied.
